No..... :- In exercise of the powers conferred by the sub section (3) of section 457 of the Gujarat Provincial Municipal Corporation Act, 1949 and insupersession of all the rules made in this behalf, the Gandhinagar Municipal Corporation hereby makes the following rules to provide for regulating recruitment to the post of Junior Town Planner, class II, in the Gandhinagar Municipal Corporation, namely:-

1. (a) These rules may be called the Junior Town Planner, class II, in the Gandhinagar Municipal Corporation Recruitment Rules 2017.
(b) They shall come into force at once.

2. Appointment to the post of Junior Town Planner, class II, in the Gandhinagar Municipal Corporation shall be made either:-
 - (a) by promotion of a person of proved merit and efficiency from amongst the persons who :
 - (i) have worked for not less than seven years in the cadre of Planning Assistant, Class-III, in the Gandhinagar Municipal Corporation or previously working in the notified area office, Gandhinagar and absorbed in the Gandhinagar Municipal Corporation,
 - (ii) have passed the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency (Training and Examination) Rules, 2006; or the examination for computer knowledge as may be prescribed by the Gandhinagar Municipal Corporation.

Provided that where the appointing authority is satisfied that a person having the experience specified in sub clause (i) above is not available for promotion and that it is necessary in the

public interest to fill up a post by promotion even of a person having experience for a lesser period; it may, for reasons to be recorded in writing, promote such person who possesses experience of a period of not less than two thirds of the period specified in sub clause (i) above; or

- (b) by direct selection; or
- (c) by temporary transfer on deputation basis from amongst the persons working on the cadre of Junior Town Planner, Class II in Government and possess the educational qualification as prescribed in sub rule (b) of rule 3 for direct selection of these rules.

3. To be eligible for appointment by direct selection to the post mentioned in rule - 2, a candidate shall -

- (a) not be less than 18 years and not be more than 42 years of age;

Provided that the upper age limit may be relaxed in favour of a candidate belonging to Scheduled Castes or Scheduled Tribes or Socially and Educationally Backward Classes or Economically Weaker Sections or Women in accordance with the provisions of the sub rule (2) of rule 8 of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967.

Provided further that the upper age limit shall not apply to the candidate who is already in the service of the Gandhinagar Municipal Corporation either as a permanent or temporary servant or previously working in the notified area office, Gandhinagar and absorbed in the Gandhinagar Municipal Corporation and appointed on the regular pay scale and he is officiating continuously for six months or more.

Provided further that the upper age limit may also be relaxed in favour of a candidate who is working in the Gandhinagar Municipal Corporation on contract basis atleast for a period of not less than six months at the time of his application for direct selection and he is in the service of Gandhinagar Municipal Corporation on the date of offer of appointment to the post, in the event of his selection

on the post, to the extent of equal number of months for which service has been put in by him.

- (b) possess
- (i) a bachelor degree in Architecture or Civil Engineering of any of the Universities established or incorporated by or under the Central or State Act in India or any other educational institution recognized as such or declared to be a deemed university under section 3 of the University Grants Commission Act, 1956; and
 - (ii) a post graduate degree or diploma in City Planning or Town Planning or Traffic or Transportation Planning or Regional Planning or Urban Design of any of the Universities established or incorporated by or under the Central or State Act in India or any other educational institution recognized as such or declared to be a deemed university under section 3 of the University Grants Commission Act, 1956, or a membership obtained by an examination of institute of Town Planners of India;
- (c) possess the basic knowledge of computer application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967; and
- (d) (i) have atleast five years experience on the post not below the rank of Planning Assistant in Gandhinagar Municipal Corporation; or
(ii) have atleast five years experience in the field of civil engineering or urban planning or city planning or town planning in Government or local bodies or Government undertaking board or corporation or limited company established under the companies Act, 2013 on the post which can be considered equivalent to the post not below the rank of Planning Assistant in Gandhinagar Municipal Corporation,
- (e) possess adequate knowledge of Gujarati or Hindi or both.

A candidate appointed by direct selection shall be on probation for a period of two years.

5. A candidate appointed by direct selection shall during his probation period, be required to pass the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency (Training and Examination) Rules, 2006 or the examination for computer knowledge as may be prescribed by the Gandhinagar Municipal Corporation.
6. A candidate appointed by direct selection will be required to pass an examination in Hindi or Gujarati or both in accordance with the rules prescribed by the Gandhinagar Municipal Corporation.
7. A candidate appointed either by direct selection or by promotion shall have to undergo such training and to pass such examination as may be prescribed by the Gandhinagar Municipal Corporation.
8. A candidate appointed by direct selection will be required to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by the Gandhinagar Municipal Corporation.
