No.GSH - 8 - 2011/ FDE-2005-254/M(1):- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, and in supersession of all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of Law Officer, Class II, in the Gujarat Industrial Safety and Health Service, under the Directorate Industrial Safety and Health namely:-

1. These rules may be called the Law Officer, Class II, in the Gujarat Industrial Safety and Health Recruitment Rules, 2011.
2. Appointment to the post of Law Officer, Class II, in the Gujarat Industrial Safety and Health shall be made by direct selection.
3. To be eligible for appointment by direct selection to the post mentioned in rule 2, a candidate shall;

- (a) not be more than 31 years of age;
- (b) possess:-
- (i) a special degree in law obtained from any of the Universities or institutions established or incorporated by or under the Central or State Act in India; or any other educational institution recognized as such or declared deemed to be as University under section 3 of University Grants Commission Act, 1956 or possess an equivalent qualification recognized by the Government for this purpose;
- (ii) the basic knowledge of computer application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967.
- (c) have about three years experience to conduct the cases in criminal courts, after acquiring the requisite educational qualification as prescribed in sub clause(i) of clause (b)of rule 3.
- (d) possess adequate knowledge of Gujarati and/or Hindi;

Provided that the upper age limit may be relaxed in favour of a candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967.

4. The candidate appointed by direct selection shall be on probation for a period of two years.

5. The candidate appointed by direct selection shall, during his probation period be required to pass the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006.

6. The candidate appointed by direct selection shall, during his probation period be required to undergo pre-service training and pass the post training examination in accordance with the provision of the Gazetted officer (Pre service training and examination) Rules, 1970.

7. The selected candidate shall be required to pass the departmental examination and an examination in Hindi or Gujarati or both in accordance with the rules prescribed by the Government from time to time.

8. The candidate appointed by direct selection shall have to undergo such training and to pass such examination as may be prescribed by the Government from time to time.

9. The selected candidate shall be required to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by the Government from time to time.

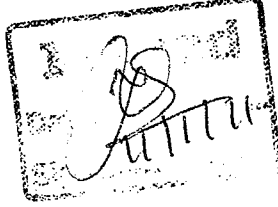

No.GSH 2019/08,PDF 102014 463862 M(1) :- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Gujarat hereby makes the following rules further to amend the Law Officer, Class II, in the Gujarat Industrial Safety and Health Recruitment Rules, 2011, namely :-

1. These rules may be called the Law Officer, Class II, in the Gujarat Industrial Safety and Health Recruitment (Amendment) Rules, 2019.
2. In the Law Officer, Class II, in the Gujarat Industrial Safety and Health Recruitment Rules, 2011 (hereinafter referred to as "the said rules"), in rule 3, for clause (a), the following shall be substituted, namely :-


"(a) not be more than 41 years of age" ✓

Provided that the upper age limit may be relaxed in favor of the candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967."

Provided further that nothing contained in clause (b) of sub rule (9) of rule 8 of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967 shall be applicable in so far as relaxation of upper age limit as prescribed above is concerned

3. In the said rules, the proviso to rule 3 shall be deleted.
