CONSTITUTION
OF INDIA.

No. GP-5-MKM-102013-1791(1)-CHH :- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of Principal/Superintendent (Homoeopathy) Class I, in the General State Service, in the Government Homoeopathy Colleges and allied Homoeopathy institutes under the Directorate of AYUSH (Ayurveda, Yoga and Naturopathy, Unani, Siddha and Homoeopathy), Gujarat State namely :-

- 1 These rules may be called the Principal/Superintendent (Homoeopathy) Class I, Recruitment Rules, 2019.
- 2 Appointment to the post of Principal/Superintendent (Homoeopathy), Class I, in the General State Service, under the Directorate of AYUSH (Ayurveda, Yoga and Naturopathy, Unani, Siddha and Homoeopathy), shall be made either:
 - (a) by promotion of a person on the basis of principle of selectivity within the zone of consideration irrespective of seniority in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967 from amongst the persons, who:
 - (i) have worked for not less than five years in the cadre of Professor (Homoeopathy), Class I, in the General State Service, under the Directorate of AYUSH (Ayurveda, Yoga and Naturopathy, Unani, Siddha and Homoeopathy).
 - (ii) have passed the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat

Civil Services Computer Competency Training and Examination Rules 2006, and

- (iii) Possess the educational qualifications as prescribed in clause (b) of rule (3) for direct selection.

Provided that the teachers appointed to the post of Professor prior to the Notification No.12-10/2000-CCH (Pt. III) of Central Council of Homoeopathy, dated the 8th March, 2013, in recognized Homoeopathic college shall be promoted as per the provisions of regulations under which they were appointed.

Provided further that where the appointing authority is satisfied that a person having experience specified in sub-clause (i) above is not available for promotion and it is necessary in the public interest to fill up the post by promotion even of a person having experience for a lesser period; it may, for reasons to be recorded in writing, promote such person who possesses experience of a period of not less two-thirds of the period specified in sub-clause (i) above; or

(b) by direct selection.

- 3 To be eligible for appointment by direct selection to the post mentioned in rule 2, a candidate shall,-

- (a) not be more than 49 years of age :

Provided that the upper age limit may be relaxed in favour of the candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967;

- (b) possess a post Graduate degree in Homoeopathy in one of the subject included in the second Schedule of the Homeopathic Central Council Act, 1973 obtained from any of the Universities established

or incorporated by or under the Central or a State Act in India; or any other educational institution recognized as such or declared to be a deemed as a University under section 3 of the University Grants Commission Act, 1956 and ;

(c) have at least two years' experience of teaching in the concerned subject in a Homoeopathic College of Degree level recognized by the Central Council of homoeopathy on the post which can be considered equivalent to the post not below the rank of Professor (Homoeopathy), Class I in Government.

(d) possess basic knowledge of computer application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967; and

(e) have adequate knowledge of Gujarati or Hindi or both.

- 4 The Candidate appointed by direct selection shall be on probation for a period of two years.
- 5 The candidate appointed by direct selection during his probation period, shall be required to undergo pre-services training and to pass the post-training examination in accordance with the provisions of the Gazetted officer's Pre-service Training and Examination Rules, 1970.
- 6 The candidate appointed by direct selection during his probation period, shall be required to pass the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006.
- 7 The candidate appointed by direct selection shall be required to pass an examination in Hindi or Gujarati or both in accordance with the rules prescribed by the Government.
- 8 The candidate appointed by direct selection shall be required to get

himself registered with the Gujarat Homoeopathic Council under the Gujarat Homoeopathic Act, 1963 at the time of appointment, if he is not so registered.

- 9 The candidate appointed either by promotion or by direct selection shall be required to undergo such training and to pass such examination as may be prescribed by the Government.
- 10 The candidate appointed by direct selection shall be required to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by Government.

No.GP-21-MKM-102013-1791(1)-CHH :- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Gujarat hereby makes the following rules further to amend the Principal/Superintendent (Homoeopathy) Class I, Recruitment Rules, 2019, namely :-

1. These rules may be called the Principal/Superintendent (Homoeopathy) Class I, Recruitment (Amendment) Rules, 2022.
2. In the Principal/Superintendent (Homoeopathy) Class I, Recruitment Rules, 2019, (hereinafter referred to as "the said rules") in rule 2, in clause (a), for the words "by promotion of a person on the basis of the principle of selectivity within the zone of consideration irrespective of seniority in accordance with the provisions of the", the words "by promotion of a person who possess 'very good bench mark' for being considered fit for promotion within the zone of consideration as laid down in the" shall be substituted.
3. In the said rules, in rule 3, in clause (c), the words "in the concerned subject" shall be deleted.
