1. The result of the Competitive Examination (Main) for the post of Chief Officer, Class-III (Advertisement No. 11/2022-23) held on 01-June-2023 and 3-June-2023 is hereby declared as per **Annexure-I**.
2. The above result is declared taking into consideration the provisions of the Chief Officer, Class III, in the Gujarat State Municipal Chief Officers' Service (Competitive Examination) Rules, 2016, dated 18th July, 2016 and amendments made thereafter from time to time and other relevant applicable criteria.
3. As provided in the Gujarat State Municipal Chief Officers' Service (Competitive Examination) Rules, 2016, dated 18th July, 2016 and amendments made thereafter from time to time,
  - (i) As per Rule-14(1) : the merit has been prepared on the basis of the aggregate marks finally awarded to each candidate in the Main Examination (i.e. 400 marks of written examination).
  - (ii) As per Rule 15 : **Waiting List** is prepared by the Commission.
- 3.1 With regard to women reservation, the result is prepared taking into consideration the Government Notification GAD No. GS/97-13-CRR/1096/2213/G-2, dated 9th April, 1997, GAD Circular No. CRR/1096/2213/G-2, dated 22/05/1997 and GAD Resolution No. CRR/1096/2213/G-2 (Part-1), dated 11/11/2014.
4. (A) For Selection to the reserved posts for Disabled candidates the cut-off Marks of the last meritorious candidate in the select list has been considered as per the Commission's Office Order Dated 22-09-2021. All such candidates are accommodated against the reserved posts for disabled category, available for allotment in their respective categories. Applicable disability Level & Type of disability for the post as provided in the

Recruitment Advertisement is referred while considering a post for PD Candidates.

- (B) For Selection to the reserved posts for Ex-Serviceman candidates the cut-off Marks of the last meritorious candidate in the select list has been considered as per the Commission's Office Order Dated 16-11-2021. All such candidates are accommodated against the reserved posts for Ex-serviceman category, in their respective categories.
- (C) The result is prepared following the ratio laid down by the following Judgements of the Hon'ble Supreme Court:
- (i) Rajesh Kumar Daria V/s. Rajasthan Public Service Commission, - Civil Appeal Nos. 3132 of 2007, 3773 of 2007 decided on 18-07-2007.
  - (ii) Public Service Commission, Uttaranchal V/s. Mamta Bist & Others, - Civil Appeal Nos. 5987 of 2007, with Civil Appeal No.5982 of 2007 decided on 03-06-2010.
