In exercise of the powers conferred by the sub section (3) of section 457 of the Gujarat Provincial Municipal Corporation Act, 1949 and insupercession of all the rules made in this behalf, the Gandhinagar Municipal Corporation hereby makes the following rules to provide for regulating recruitment to the post of Sub Fire Officer, in the Gandhinagar Municipal Corporation, namely:-

1. (a) These rules may be called the Sub Fire Officer, in the Gandhinagar Municipal Corporation Recruitment Rules, 2020.
(b) They shall come into force at once.

2. Appointment to the post of Sub Fire Officer, in the Gandhinagar Municipal Corporation shall be made either:-
 - (a) by promotion of a person of proved merit and efficiency from amongst the persons who :
 - (i) have worked for not less than five years in the cadre of Leading Fireman / Jamadar or Driver in fire service in the Gandhinagar Municipal Corporation or previously working in the notified area office, Gandhinagar and absorbed in the Gandhinagar Municipal Corporation;
 - (ii) have passed the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency (Training and Examination) Rules, 2006 or the examination for computer knowledge as may be prescribed by the Gandhinagar Municipal Corporation; and
 - (iii) possess the certificate of fire fighting course from a recognized institution or possess an equivalent qualification as may be prescribed by the Gandhinagar Municipal Corporation.

Provided that where the appointing authority is satisfied that a person having the experience specified in sub clause (i) above is not

available for promotion and that it is necessary in the public interest to fill up a post by promotion even of a person having experience for a lesser period; it may, for reasons to be recorded in writing, promote such person who possesses experience of a period of not less than two thirds of the period specified in sub clause (i) above; or

(b) by direct selection.

3. To be eligible for appointment by direct selection to the post mentioned in rule – 2, a candidate shall –

(a) not be less than 18 years and not be more than 40 years of age;

Provided that the upper age limit may be relaxed in favour of a candidate belonging to Scheduled Castes or Scheduled Tribes or Socially and Educationally Backward Classes or Economically Weaker Sections or Women in accordance with the provisions of the sub rule (2) of rule 8 of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967.

Provided further that the upper age limit shall not apply to the candidate who is already in the service of the Gandhinagar Municipal Corporation either as a permanent or temporary servant or previously working in the notified area office, Gandhinagar and absorbed in the Gandhinagar Municipal Corporation and appointed on the regular pay scale and he is officiating continuously for six months or more.

Provided further that the upper age limit may also be relaxed in favour of a candidate who is working in the Gandhinagar Municipal Corporation on contract basis atleast for a period of not less than six months at the time of his application for direct selection and he is in the service of Gandhinagar Municipal Corporation on the date of offer of appointment to the post, in the event of his selection on the post, to the extent of equal number of months for which service has been put in by him.

- (b) possess. -
- (i) a degree of any of the Universities established or incorporated by or under the Central or State Act in India or any other educational institution recognized as such or declared to be a deemed university under section 3 of the University Grants Commission Act, 1956;
 - (ii) a certificate of sub-divisional officer course of National Fire Service College, Nagpur, or possess an equivalent qualification as may be determined by the Gandhinagar Municipal Corporation,
 - (iii) the basic knowledge of computer application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967,
 - (iv) minimum requisite standards of physique as specified in annexure annexed to these rules.
 - (v) adequate knowledge of Gujarati or Hindi or both
- (c)
- (i) have atleast three years experience on the post of Leading Fireman / Jamadar or Driver in fire services in Gandhinagar Municipal Corporation, or previously working in the notified area office, Gandhinagar and absorbed in the Gandhinagar Municipal Corporation, or
 - (ii) have atleast three years experience of fire service in Government or local bodies or Government under taking board or corporation or limited company established under the companies Act, 2013. and
- (d) have passed the physical efficiency test and practical test of swimming as may be prescribed by the Gandhinagar Municipal Corporation.
4. Notwithstanding anything contained in any rules, a candidate selected by direct recruitment shall be appointed on contract basis for five years on such terms and conditions as prescribed by the Gandhinagar Municipal Corporation.
 5. A candidate appointed under rule 4 shall be given the prescribed pay scale of the post of Sub Fire Officer after completion of contractual period, on his performance being found satisfactory during the stipulated period of service on contract basis.
 6. A candidate appointed under rule 4, shall during the stipulated period of service on contractual basis, be required to pass the CCC examination for computer knowledge as prescribed in Gujarat Civil Services Computer Competency Training and

Examination Rules, 2006 or the examination for computer knowledge as may be prescribed by the Gandhinagar Municipal Corporation.

7. A candidate appointed in accordance with rule-4 shall, after regular appointment, be required to pass an examination of Hindi or Gujarati or both, as the case may be, in accordance with the rules prescribed by the Gandhinagar Municipal Corporation.
8. A candidate appointed either by direct selection or by promotion shall have to undergo such training and to pass such examination as may be prescribed by the Gandhinagar Municipal Corporation.
9. A candidate appointed by direct selection shall be required to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by the Gandhinagar Municipal Corporation.

Minimum Physical Standard for the post of Sub Fire Officer.
Norms to be taken in to consideration by the Medical officer.

Physical Standards:

- A. All Male candidates should be physically fit as per standards for different classes of persons as specified below.

* Minimum expansion of chest when inflated shall not be less than 5 Centimeters.

- B. All female candidates should be physically fit as per standards for different classes of persons as specified below.

Other candidate (except Scheduled Tribes of Gujarat origin)	162 centimeters	40 kilogram

C. Candidates who have got any one or more of the following physical defects shall be considered physically unfit:

Knock knee, pigeon Chest, Squint Eye, Flat Feet, Varicose Veins, Hammer Toes, Fractured Limb, Decayed Teeth, Communicable / Skin Disease.
