Note :-

- (1) The EWS candidate at Merit No. 11; the SEBC candidates at Merit Nos. 01 (Fem.), 04 (Fem.) & 14 and the S.C. candidate at Merit No. 02, are to be recommended for appointment on unreserved post as per G.A.D. Circular No. PVS-1099-MM-13-G4, dated 29/01/2000, PVS-2010-03-900-G4, dated 23/07/2004 and PVS-102019-221-G4, dated 07/02/2019, as they have not availed any relaxation in age / Cut-Off Marks in Main Written Examination.
- (2) The candidates at Merit Nos. 07, 08, 09, 10, 12 and 13, though have secured their place in the merit of General Category, but due to better preference available to them, they are selected against the post reserved for their respective Categories in accordance with the provisions of Rule 14 (2) and the Judgement of the Honourable Supreme Court in the case of Union of India versus Ramesh Ram and others (Civil Appeal No. 4310-4311 of 2010) [Arising out of SLP(C) Nos. 13571-72 of 2008].
- (3) In case of equal marks, the merit is assigned taking into consideration the date of birth (i.e. preference is given to the elder).
- (4) 01 post of S.C. and 02 posts of S.T. category remains vacant as no candidates were available for the interviews.
