CORRIGENDUM

- 1 The Final result for the recruitment to the various posts in G.A.S., Class-I, Gujarat Civil Services, Class-I & II and Gujarat Municipal Chief Officer Service, Class-II, Advt. No. 10/2019-20 was declared by the Commission on 1st September, 2021 vide Notification No:- CCE-2019-766-(9)-EX-1 annexed with Annexure-I.
- 2 Now, subsequent to receiving the applications for rechecking of marks from the list of successful and unsuccessful candidates as listed respectively at Part-I and Part-II of the Annexure- I, scrutiny of the answer-books was conducted by the Commission and it is observed that
 - a. On rechecking of the answer-sheet of Question Paper-I of the candidate bearing Roll No. 101028945, it has been found that the Sub- Question No. 4.5 of the Question No. 4 written by the candidate has not been evaluated. The candidate scores 01 (one) mark on evaluation of the above question and hence his final aggregate marks and the merit order stands revised.
3. Subsequent to the above stated revision, merit position of the above candidate is changed.
 - a. The candidate bearing Roll No. 101028945, Shri Kuldipkumar Ajitbhai Vadher has secured total 453.25 in the final result published on 1st September, 2021. Now he get total 454.25 marks. Hence in view of the merit position, this roll no. is shifted from merit No. 91 to Merit No. 88a in Part-I(List of successful candidates) and treated as SEBC-10 as per the available posts according to his preference. Consequently, the candidate bearing Roll No. 101012979, Shri Nikinkumar Sevaklal Jayswal at merit No. 89 in Part-I(List of successful candidates) is treated as G-45 as per the available posts according to his preference.
