Add the following:

- (e) The candidate appointed by direct selection in class I and II shall be on probation for a period of two years.
- (f) The candidate appointed by direct selection in class III shall be on contract basis for a period of five years.
3. Notwithstanding anything contained in any rules, a candidate selected by direct recruitment in class III shall be appointed on contract basis for five years on such terms and conditions as prescribed by the Gujarat Water Resources Development Corporation Limited.
4. The candidate appointed under rule-3 shall be granted the prescribed pay scale of the class III after completion of contractual period, on his performance being found satisfactory during the stipulated period of service on contract basis.

No. G.W.R.D.C./CS/3902 :- In exercise of the powers conferred by the clause 23 of article 189 of the Memorandum and Articles of Association of the Gujarat Water Resources Development Corporation Limited, the Board of Director of the Gujarat Water Resources Development Corporation Limited hereby makes the following rules further to amend the post of as per Annexure-I, namely:-

1. These rules may be called the Recruitment (Amendment) Rules, 2023 post of as per Annexure-I.
2. In the words "Gujarat Civil Services Classification and Recruitment (General) Rules, 1967" read as follows to the post of as per Annexure-I :-

“Recruitment process of this cadre shall be conducted either, by Gujarat Water Resources Development Corporation Limited, or by Gujarat Public Service Commission after passing the appropriate of Government, in case of Gujarat Public Commission would conduct this recruitment process;


- (a) Provision of Rules and Office order of Gujarat Public Service Commission shall be applicable,
- (b) Following Rules of Gujarat Civil Service Classification and Recruitment (General) Rules 1967 shall be applicable.

- (c) After final selection, successful candidate shall be considered as Gujarat Water Resources Development Corporation Limited employee, not a Government employee.
- (d) Government provisions regarding preparing waiting list shall be applicable.
- (e) The candidate appointed by direct selection in class I and II shall be on probation for a period of two years.
- (f) The candidate appointed by direct selection in class III shall be on contract basis for a period of five years.

3. Notwithstanding anything contained in any rules, a candidate selected by direct recruitment in class III shall be appointed on contract basis for five years on such terms and conditions as prescribed by the Gujarat Water Resources Development Corporation Limited.
4. The candidate appointed under rule-3 shall be granted the prescribed pay scale of the class III after completion of contractual period, on his performance being found satisfactory during the stipulated period of service on contract basis.
