CONSTITUTION
OF INDIA.

No. GH/ J /SSP/152010/812271/A:- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of Principal, class II in Government Residential School for Socially and Educationally Backward Class in General State Services under the Directorate of Developing Caste Welfare, namely:-

1. These rules may be called the **Principal, Class II Recruitment Rules, 2013.**
2. Appointment to the post of Principal, class II in Government Residential School for Socially and Educationally Backward Class in General State Service under the Directorate of Developing Caste Welfare shall be made either,
 - (a) by promotion of a person of proved merit and efficiency from amongst the persons who,
 - (i) have worked for not less than seven years in the Cadre of Assistant Teacher, Class III in Government Residential School for Socially and Educationally Backward Class in the subordinate services of the Directorate of Developing Caste Welfare; and
 - (ii) have passed the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules 2006;

Provided that where the appointing authority is satisfied that a person having the experience specified in sub-clause (i) above is not available for promotion and that it is necessary in the public interest to fill up a post by promotion even of a person having experience for a lesser period; it may, for reasons to be recorded in writing, promote such person who possesses experience of a period of not less than two-thirds of the period specified in sub-clause (i) above; or

- (b) by direct selection.

3. To be eligible for appointment by direct selection to the post mentioned in rule 2, a candidate shall,-

- (a) not be more than thirty five years of age:

Provided that the upper age limit may be relaxed in favour of a candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967.

- (b) possess,-

- (i) a post graduate degree with atleast 55% of the marks or its equivalent grade B in the seven point scale with letter grades O, A, B, C, D, E and F at the master degree level from any of the Universities established or incorporated by or under

- the Central or State Act in India; or any other educational institution recognized by the Government as such or declared to be a deemed University under section 3 of the University Grants Commission Act, 1956; or possess an equivalent qualification recognized as such by the Government; and
- (ii) a bachelor degree in education with at least 60% of the marks or its equivalent grade B in the seven point scale with letter grades O, A, B, C, D, E and F at the degree level from any of the Universities established or incorporated by or under the Central or State Act in India; or any other educational institution recognized by the Government as such or declared to be a deemed University under section 3 of the University Grants Commission Act, 1956 or possess an equivalent qualification recognized as such by the Government;

Explanation :-

1. Where the University or College or Institution declares results in grade point, which is on a scale of seven point, the following mechanism shall be referred to ascertain equivalent marks in percentage.

Grade.	Grade Point.	Percentage equivalent.
'O' -Outstanding	5.50-6.00	75-100
'A' -Very Good	4.50-5.49	65-74
'B' -Good	3.50 - 4.49	55-64
'C' -Average	2.50 - 3.49	45-54
'D' -Below Average	1.50-2.49	35-44
'E' -Poor	0.50-1.49	25-34
'F' -Fail	0-0.49	0-24

- (c) have about five years experience as a teacher or principal in Government Schools or Grant in aid schools or recognized private or public sector schools.
 - (d) possess the basic knowledge of computer application as prescribed in Gujarat Civil Services Classification and Recruitment (General) Rules, 1967.
 - (e) possess adequate knowledge of Gujarati or Hindi or both.
4. The candidate appointed by direct selection shall be on probation for a period of two years.
 5. The candidate appointed by direct selection shall, during his probation period, require to pass the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency (Training and Examination) Rules, 2006.

6. The candidate appointed by direct selection shall, during his probation period require to undergo pre-service training and pass the post training examination in accordance with the provisions of the Gazetted Officer's pre-service (Training and Examination) Rules, 1970.
 7. The candidate appointed by direct selection shall require to pass an examination in Hindi or Gujarati or both in accordance with the rules prescribed by the Government.
 8. The candidate appointed either by promotion or by direct selection shall have to undergo such training and pass such examination as may be prescribed by the Government.
 9. The candidate appointed by direct selection shall require to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by the Government.

No. GH/9/SSP/152010/812271/A:- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Gujarat hereby makes the following rules further to amend the Principal, Class II, Recruitment Rules, 2013, namely :-

1. These rules may be called the Principal, Class II, Recruitment (Amendment) Rules, 2014.
2. In the Principal, Class II, Recruitment Rules, 2013, in rule 3,-
 - (i) in clause (a), for the words "thirty five years", the words "thirty eight years" shall be substituted;
 - (ii) For clause (c), the following clause shall be substituted, namely :-

"(c) have about five years combined or separate experience of teaching or inspecting of educational institutions or administration in educational institutions recognised by the Government after obtaining the academic qualification as specified in clause (ii) of sub-rule (b) above."

No. GHL/14/SSP/152010/812271/A :- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Gujarat hereby makes the following rules further to amend the Principal, Class II, Recruitment Rules, 2013, namely :-

1. These rules may be called the Principal, Class II, Recruitment (Amendment) Rules, 2016.
2. In the Principal, Class II, Recruitment Rules, 2013, in rule 3, in clause (a),-
 - (i) for the figures and words "38 years", the figures and words "43years" shall be substituted;
 - (ii) after the existing proviso, the following proviso shall be inserted, namely :-

"provided further that nothing contained in clause(b) of sub-rule(9) of rule 8 of the Gujarat Civil Services Classification and Recruitment(General) Rules,1967 shall be applicable in so far as relaxation of upper age limit as prescribed above is concerned."

1. These rules may be called the Principal, Class II, Recruitment (Amendment) Rules, 2020.
2. In the Principal, Class II, Recruitment Rules, 2013, (hereinafter referred to as "the said rules") in rule 2, in clause (a), for the words "by promotion of a person of proved merit and efficiency ", the words, brackets and figures "by promotion of a person who possess 'good' benchmark for being considered fit for promotion within the zone of consideration as laid down in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967" shall be substituted.
3. In the said rules in rule 3, in clause (a). for the figures and word "43 years", the figures and word "44 year" shall be substituted.
