CONSTITUTION OF INDIA

No.GHKH-61-2010-GR/3069/2803/5.2:- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, and in supersession of all the rules in this behalf the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of the Assistant Director of Horticulture/Subject Matter Specialist, Class-II in the Gujarat Horticulture Service, under the Directorate of Horticulture, namely:-

1. These rules may be called the Assistant Director of Horticulture / Subject Matter Specialist, Class-II Recruitment Rules, 2010.
2. Appointment to the post of the Assistant Director of Horticulture / Subject Matter Specialist shall be made either,
 - (a) by promotion of a persons of proved merit and efficiency from amongst the persons who-
 - (i) have worked for not less than five years in the cadre of Horticulture Officer, Class-II, and
 - (ii) have passed the departmental examination.
 - (iii) have passed the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules 2006.

Provided that where the appointing authority is satisfied that a person having the experience specified in sub-Clause (i) above is not available for promotion and that it is necessary in public interest to fill up a post by promotion even of a person having experience for a lesser period, it may for reasons to be recorded in writing, promote such person who possesses experience of a period of not less than two thirds of the period as specified in sub-clause (i) above, or

- (b) by direct selection

- (c) by temporary transfer on deputation basis from amongst the persons working in the cadre of Assistant Director of Agriculture in Gujarat Agriculture Service, Class-II.
3. The appointments by promotion and direct selection shall be made in the ratio of 2 : 1 respectively.
4. To be eligible for appointment by direct selection to the post mentioned in rule 2, a candidate shall-
- (1) not be more than 31 years of age;
 - (2) possess.
 - (a) a second class master degree in any branch of Horticulture,
 - or
 - (b) (i) a second class bachelor's degree in any branch of Horticulture, and
(ii) have at least three years experience in Horticultural Research or Horticultural Extension Service, Horticultural Education and Horticultural Engineering.
 - (c) The qualification specified in clauses (a) & (b) shall have been obtained from any of the Universities or institutions established or incorporated by or under the Central or State Act, in India or any other educational institution recognized as such or declared as to be deemed as University under section 3 of the University Grant Commission Act, 1956.
 - (3) Possess the basic knowledge of computer application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967:

Provided that the upper age limit may be relaxed in favour of a candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967.
 - (4) Possess adequate knowledge of Gujarati and/or Hindi.
5. The candidate appointed by direct selection shall be on probation for a period of two years.
6. The candidate appointed by direct selection shall during his probation period be required to pass the qualifying examination for computer knowledge in accordance with the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006.
7. The candidate appointed by direct selection shall, during his probation period be required to undergo Pre-service training and to pass the post training examination in accordance with the Gazetted Officer's Pre-service Training and Examination Rules, 1970.
8. The selected candidate shall be required to pass the departmental examination, and an examination in Gujarati or Hindi or both in accordance with the rules prescribed by the Government.
9. The candidate appointed either by promotion or by direct selection shall be required to undergo such training and pass such examination as may be prescribed by the Government.
10. The candidate appointed by direct selection shall be required to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by the Government from time to time
