Note :-

- (1) The General Category candidate at Merit No. 4 and the candidate kept on waiting list for General Category, at serial No. 01, possess post graduate degrees in concerned subject (Swasthvritta), and hence they have been preferred for selection over the remaining General category candidates possessing post graduate degrees in allied subject (Kaya Chikitsa), as per the provisions stated in rule 5 (b) of the recruitment rules.
- (2) As the required number of General Category candidates with post graduate degrees in the concerned subject (Swasthavritta) are available for selection, the SEBC Category candidate, at Merit No. 01, though has obtained more aggregate marks than the general category candidates, he is to be recommended for appointment against the post reserved for SEBC category, as he possesses a post graduate degree in allied subject (Kaya Chikitsa).
- (3) **The Weighted Marks of Preliminary Test & Interview are calculated as follows :-**

$$[\text{Marks obtained in P.T.} \times 50/300 = \text{Weighted Marks of Preliminary Test}] + [\text{Marks obtained in Interview} \times 50/100 = \text{Weighted Marks of Interview}] = \text{Total Weighted Marks}$$
- (4) The above result shall be subject to the final decision of the Hon'ble High Court in SCA Nos. 13618/2017 to SCA No. 13624/2017, S.C.A. No. 8966/2017, S.C.A. No. 10445/2017, L.P.A. No. 1203/2018 in S.C.A. No. 8966 of 2017 and other related matters.
