

Gujarat Public Service Commission CORRIGENDUM

Advertisement No. 40/2018-19 (Final Result)

- The Final result for the recruitment to the various posts in G.A.S., Class-I, Gujarat Civil Services, Class-I & II and Gujarat Municipal Chief Officer Service, Class-II, Advt. No. 40/2018-19 for which written test were held on 17th & 24th February & 3rd March, 2019 and personal interview were held during 10th to 28th June, 2019 was declared by the Commission on 4thJuly, 2019 vide Notification No:- CCE-2018-711-(16)-EX annexed with Annexure-I. The final result was revised partially and a corrigendum was issued on dt.6-7-2019.
- 2 Now, subsequent to receiving the applications for rechecking of marks from the list of successful and unsuccessful candidates as listed respectively at Part-I and Part-II of the Annexure- I, scrutiny of the answer-books was conducted by the Commission and it is observed that
 - a. On rechecking of the answer-sheet of Question Paper-V of the candidate bearing Roll No. 119192714, it has been found that the question No. 22 (optional question & 10th answer under section B) written by the candidate has not been evaluated. The candidate scores 04 (four) marks on evaluation of the above question and hence her final aggregate marks and the merit order stands revised.
 - b. Subsequent to the supplying the answer sheet to the candidates after final result published, the commission has received the application from the candidate bearing Roll No. 115154513 that he has received wrong answer sheet of Paper-V i.e. it does not belong to him. On scrutiny and detection of the facts, it appeared that the candidates having back and forth seating arrangement during Main(Descriptive) exam have erroneously interchanged their barcode stickers and applied on their respective answer-sheets for Paper-V only. The Answer-sheets are identified by barcode stickers pasted on it hence, the answer-sheet of Roll No. 113130972 was identified as answer-sheet of Roll No. 115154513 and vice versa. This has resulted into the interchange of marks for paper-V hence required to be set-right. Accordingly, Final aggregate marks of these candidates are revised taking into consideration the marks obtained in Paper-V by respective candidates after setting-right the error. As a result of this, the merit no. of the Roll No. 113130972 in Part-I of Annexure-I stands changed.

- 3. Subsequent to the above stated revisions, merit positions of the above candidates is changed.
 - a. The candidate bearing Roll No. 119192714, Kum. Monalisa Ramsingbhai Khant attained more marks than cut-off marks arrived for the ST(Female) category. Hence in view of the merit position, this roll no. is inserted at Part-I at Merit No. 293 and declared as a successful candidate. Consequently, entry of this roll no. at Sr. No. 419 at Part-II is deleted. As a result, the cut-off standard for ST(Female) stands changed and revised at 383.50 marks. Accordingly, the candidate bearing Roll No. 113138851 is now to be declared as unsuccessful with reference to the revised cut-off standard for ST (Female) Category. Entry of this roll no. at Merit No. 293 is deleted from Part-I and inserted to Part-II in the list of Unsuccessful Candidates at Sr. No. 585.
 - **b.** With setting-right of the obtained marks, the candidate bearing Roll No 113130972 with revised marks and obtained merit position is now shifted from the Merit No. 265 to Merit No. 273A. Accordingly, details stated in the "**Treated**" column stands changed from Merit No. 265. However, Inter-se allotment of posts remains unchanged. There is no change in the position of the Candidates bearing Roll no. 115154513 with reference to his revised marks.
- 4. The significant resultant modifications in Annexure-1, Part-I "List of successful Candidates" and Part-II "List of Unsuccessful Candidates" is mentioned with details as under:-
