- (1) The SEBC Category Female candidate at Merit No. 04, Kum. Neelam Bharatbhai Modi, bearing E.No. 35 and the S.C. Category Female candidate at Merit No. 06, Kum. Varsha Pravinbhai Solanki, bearing E.No. 05, are to be recommended for appointment on unreserved posts as per Government circular, GAD No. PVS-1099-MM-13-G4 dated 29-1-2000 and PVS-2010-03-900-G4, dated 23/07/2004, as they have not availed relaxation in Qualifying Standard in Preliminary Test or in age.
- (2) The S.T. Category Female candidate at Merit No. 03, Kum. Meghana Manhar Patel, bearing E. No. 23, though secured her place in the merit of general category, however she ***is to be recommended for appointment against the post reserved for S.T. category***, as per Government circular, GAD No. PVS-1099-MM-13-G4 dated 29-1-2000 and PVS-2010-03-900-G4, dated 23/07/2004, as she has availed the benefit of relaxation in qualifying standard in the preliminary test.
- (3) The posts reserved for Disabled and Ex-servicemen, remained vacant as no candidates were available for the interviews.
- (4) The results of the 02 petitioners of S.C.A. Nos. 397 and 399 of 2019, are kept in "Sealed Covers".
- (5) The above result shall be subject to the final decision of the Hon'ble High Court in S.C.A. Nos. 397/2019, 399/2019 and 15266 of 2018.
