



CONSTITUTION OF INDIA. No.GH/SH/6/GCO/152000/5430/KH :- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of Assistant Professor, in the Government, Arts, Science and Commerce Colleges in Gujarat Educational Service, Class II, namely:-

1. These rules may be called the Assistant Professor in the Government Arts, Science and Commerce Colleges in Gujarat Educational Service, Class II, Recruitment Rules, 2011.
2. Appointment to the post of Assistant Professor, in the Government Arts, Science and Commerce Colleges in Gujarat Educational Service, Class II, shall be made by direct selection.
3. To be eligible for appointment by direct selection to the post mentioned in rule 2, a candidate shall -

(a) not be more than 30 years of age.

Provided that the upper age limit may be relaxed in favour of a candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967:

(b) possess a post graduate degree with atleast 55% of the marks or at least its equivalent grade of B in the seven point scale with letter grades O, A, B, C, D, E and F at the master

degree level in relevant subject of any of the Universities established or incorporated by or under the Central or State Act in India or any other educational institution recognised by the Government or declared deemed to be a University under section 3 of the University Grants Commission Act, 1956; or possess an equivalent degree from an accredited foreign University or possess an equivalent qualification recognized as such by the Government;

Provided that the requirement of 55% marks at the post graduate degree may be relaxed to 50% in respect for the candidate belonging to Scheduled Castes and Scheduled Tribes and different disabled (physically and visually different - abled) categories. Such relaxation shall be permissible, only on consideration of the qualifying marks:

Provided further that such relaxation shall be available to the candidate, who have completed their Ph.D. degree and have obtained Master's degree prior to the 19th September, 1991;

- (c) have cleared the National Eligibility Test (NET) / State Level Eligibility Test (SLET) for recruitment and appointment of Assistant Professors in colleges being conducted by the University Grants Commission, Council of Scientific and Industrial Research or such similar tests like State Level Eligibility Test (SLET) / State Eligibility Test (SET) accredited by the University Grants Commission.

Provided that candidates who are or have been awarded Ph.D. degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of Ph.D. Degree) Regulations, 2009, shall be exempted from the requirement of clearing of NET / SLET for recruitment and appointment of Assistant Professor or equivalent position in Colleges:

Provided further that NET / SLET / SET shall not be required for in respect of such subject for which NET / SLET / SET is not conducted.

Explanation: 1. - It is hereby clarified that where the University/College/Institution declare results in grade point which is on a scale of seven, the following mechanism shall be referred to ascertain equivalent marks in percentage:-

Explanation 2. - While relaxing to standard for eligibility for appointment in respect of certain categories as stated above, grade 'C' and 3 or more grade points shall be required;

1. These rules may be called Assistant Professor, Class-II, in the Government Law Colleges Recruitment Rules, 2011.
2. Appointment to the post of Assistant Professor, Class-II, in the Government Law Colleges in Gujarat Educational Service shall be made by direct selection.
3. To be eligible for appointment by direct selection to the post mentioned in rule 2, a candidate shall-
 - (a) not be more than 35 years of age;
 - (b) possess a post graduate degree in Law with atleast 55% of the marks or its equivalent grade of 'B' in the seven point scale with letter grades O,A,B,C,D,E and F at the master degree level in a relevant subject obtained from any of the Universities established or incorporated by or under the Central or State Act in India; or any other Educational Institution recognized as such or declared deemed as University under section 3 of the University Grants Commission Act, 1956 or possess an equivalent two year degree from an accredited foreign University.

Explanation :-where the University or College or Institution declare results in grade point which is on a scale of seven, the following criteria shall be adopted to ascertain equivalent marks in percentage; namely:-

Provided that 5% of marks may be relaxed at the master's degree level to the candidate belonging to Scheduled Castes and Scheduled Tribes and differently-abled (physically and visually differently-abled) categories. The relaxation shall be permissible, only on the qualifying marks without including grace marks, if any; such relaxation shall be permissible, based on only on consideration of the qualifying marks:

Provided further that such relaxation of 5% shall be available to the candidate, who posses Ph.D. degree and has obtained Master's degree prior to the 19th September, 1991;

(d) possess the basic knowledge of Computer Application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967; and

(a) possess adequate knowledge of Gujarati or Hindi or both.




