- (2) As per the Hon'ble High Court's Oral Order dated 24/08/2022 in LPA No. 1091 of 2022 in SCA No. 9933 of 2022 and LPA No. 1092 of 2022 in SCA No. 1672 of 2022, Candidates Bearing E. No. 08 & 07 were called for Interview conditionally. The Minutes of all the candidates, who appeared in the interview was kept in "**Sealed Cover**" as per the Hon'ble High Court's Oral Order dated 24/08/2022. The Sealed Cover was produced before the Hon'ble High Court on 19/09/2022. As per the common oral order dated 19/09/2022, both the appeals were disposed of by the Hon'ble High Court with remarks in para-4 - "**As far as Appeal filed by present appellant Shri Jitendrakumar Kalidas Gondaliya is concerned, who is put in Waiting List, it would be open for him to revive the Appeal, in future if circumstances arise.**" Accordingly, as per the Commission's Decision dated 21/09/2022, the name of the appellant Shri Jitendrakumar Kalidas Gondaliya has been retained in the Waiting List.
