1. As per the Hon'ble High Court's oral order dated 01/09/2017 in SCA No. 16080 of 2017, candidate Dr. Chirag Kanakray Vibhakar, bearing E.No. 17 (Code- EAQ) has been allowed for interview and his result is kept in "**Sealed Cover**"
2. With regards to women reservation as provided for, in the Government Notification GAD No. GS/97-13-CRR/1096/2213/G-2 Dated 9th April, 1997 and GAD Circular No. CRR/1096/2213/G-2, Dated 22nd May, 1997, 02 women candidates of General Category were required to be selected. As against this, no woman candidate from General Category was available for the interview.

4. The Commission regrets its inability to recommend any candidate for the remaining 07 posts of General category as no suitable candidates were available for the same and also for 02 posts reserved for SEBC Category , 01 post reserved for S.T. category and 01 post reserved for Disabled candidates as no candidates were available for the interview.
5. The above result shall be subject to the Final decisions of the Hon'ble High Court in **SCA No. 16080 of 2017.**
