**Note :-**

- (1) The General Category Female candidate, (bearing E. No. 04), possesses a post graduate degree in allied subject (Kaya Chikitsa), hence, she has not been preferred for selection as per the rule 3(b) of the Recruitment Rules, 2013, dated 20th May, 2013 and amendments made from time to time even though she becomes eligible for selection after relaxing 10% marks of the Cut-Off marks of the General category candidate,
- (2) The SEBC Category Candidate at Merit No.4 and candidates kept on waiting list for SEBC Category, though possess Post Graduate Degrees in allied subject (Kayachikitsa) have been considered, as no SEBC Category candidates were available possessing Post Graduate Degree in concerned subject ( Swasthavritta), as per the rule 3(b) of the Recruitment Rules, 2013, dated 20th May, 2013 and amendments made from time to time.
- (3) 02 posts of Disabled category remained vacant (Advt. No. 50/2017-18 to 63/2017-18), as no candidates were available for the interview.
- (4) **The Weighted Marks of Preliminary Test & Interview are calculated as follows :-**  

$$[\text{Marks obtained in P.T.} \times 50/300 = \text{Weighted Marks of Preliminary Test}] + [\text{Marks obtained in Interview} \times 50/100 = \text{Weighted Marks of Interview}] = \text{Total Weighted Marks}$$
- (5) The above result shall be subject to the final decision of the Hon'ble High Court in S.C.A. No. 23177/2017 and other related matters.
