No. GHKH/107/2019/BGM/1015/77/k.8: In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of Horticulture Officer, Class II, in the Gujarat Horticulture Service, under the Directorate of Horticulture, Gujarat State, namely:-

1. These rules may be called the Horticulture Officer, Class II, in the Gujarat Horticulture Service, under the Directorate of Horticulture Recruitment Rules, 2019.
2. Appointment to the post of Horticulture Officer, Class II, in the Gujarat Horticulture Service, Gujarat State, shall be made either,=

(a) by promotion of a person of proved merit and efficiency from amongst the persons who:

- (i) have worked for not less than seven years in the cadre of Horticulture Supervisor, Class III, in the subordinate services of the Directorate of Horticulture, Gujarat State,
- (ii) have passed the prescribed departmental examination for promotion to the post of Horticulture Officer, Class II ; and
- (iii) have passed the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006:

Provided that where the appointing authority is satisfied that a person having the experience specified in sub-clause (i) above is not available for promotion and that it is necessary in public interest to fill up the post by promotion even of a person having experience for a lesser period; it may, for reasons to be recorded in writing, promoted such person who possesses

experience of a period of not less than two-thirds of the period as specified in sub-clause (i) above; or

(b) by direct selection.

3. The appointments by promotion and by direct selection shall be made in the ratio of 1:3 respectively.

4. To be eligible for appointment by direct selection to the post mentioned in rule 2, a candidate shall,-

(a) not be more than 37 years of age:

Provided that the upper age limit may be relaxed in favour of the candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967;

(b) possess a bachelor's degree in science (Horticulture) or a post-graduate degree in Agriculture (Horticulture) obtained from any of the Agricultural/Horticultural Universities incorporated or established by or under the Central Agricultural Universities Act or State Agricultural Universities Act in India;

(c) possess the basic knowledge of computer application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967;

(d) possess adequate knowledge of Gujarati or Hindi or both.

5. The candidate appointed by direct selection shall be on probation for a period of two years.

6. The candidate appointed by direct selection shall during his probation period, be required to undergo pre-service training and pass the post-training examination in accordance with the provisions of the Gazetted Officer's Pre-service Training and Examination Rules, 1970.


7. The candidate appointed by direct selection shall during his probation period, be required to pass the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006.

8. The candidate appointed by direct selection shall be required to pass the departmental examination, prescribed by the Gujarat Agriculture Department (Conditions of Service relating to Gazetted posts in the Gujarat Horticulture Service in Class I and Class II Officer's Examination) Rules, 2004 and an examination in Gujarati or Hindi or both in accordance with the rules prescribed by the Government.

9. The candidate appointed either by promotion or by direct selection shall be required to undergo such training and pass such examination as may be prescribed by the Government.

10. The candidate appointed by direct selection shall be required to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by the Government.


