No. **GG- 28/2016/JLM/502008/4809/J**:- In exercise of the powers conferred by sub-section (10) of section 59 read with section 6 of Prisons Act, 1894(9 of 1894) and in supersession of all the rules made in this behalf, the Government of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of Superintendent, Central Prison and Superintendent, Porbandar Special Prison, in the Gujarat Jail Service, Class-I, in the Jail Department, namely :-

1. These rules may be called the Superintendent, Central Prison and Superintendent, Porbandar Special Prison, Class I Recruitment Rules, 2016.
2. Appointment to the post of Superintendent, Central Prison or Superintendent, Porbandar Special Prison, in the Gujarat Jail Service Class I shall be made either,-
 - (a) by promotion of a person who possess 'very good bench mark' for being considered fit for promotion as laid down in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967 from amongst the persons who,-
 - (i) have worked for not less than five years in the cadre of Deputy Superintendent of Central Prison or Principal, Jail Staff Training School, in the Gujarat Jail Service, Class I in the Jail Department;
 - (ii) have passed the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006:

Provided that where the appointing authority is satisfied that a person having the experience specified in sub-clause (i) above is not available for promotion and that it is necessary in the public interest to fill up the post by promotion even of a person having experience for a lesser period; it may, for reasons to be recorded in writing, promote

such person who possesses experience of a period of not less than two-thirds of the period specified in sub-clause (i) above; or

- (b) by direct selection; or
- (c) by temporary transfer, on deputation basis from amongst the persons working on the cadre of the District Superintendent of Police or equivalent in the Gujarat State Police Service, Class I; or Indian Police Service, Class I.

3. To be eligible for appointment by direct selection to the post mentioned in rule 2, a candidate shall,-

- (a) not be less than 21 years of age and not be more than 42 years of age;

Provided that the upper age limit may be relaxed in favour of a candidate who is belonging to Scheduled Castes or Scheduled Tribes or Socially and Economically Backward Classes or Women in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967:

Provided further that the upper age limit may be relaxed in favour of a candidate who is already in the service of the Government of Gujarat in accordance with the provisions of Gujarat Civil Services Classification and Recruitment (General) Rules, 1967;

Provided also that nothing contained in clause (b) of sub rule (9) of rule 8 of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967 shall be applicable in so far as relaxation of upper age limit as prescribed above is concerned;

- (b)
 - (i) possess a degree with first class of any of the Universities established or incorporated by or under the Central or a State Act in India or any other educational institution recognised as such or declared to be deemed as a University under section 3 of the University Grants Commission Act, 1956 or possess an equivalent qualification recognised by the Government; and

- (ii) have about "seven years" experience of Superintendent of District Jail, in the Gujarat Jail Service, Class II in the Jail Department or have about seven years administrative experience in Government or Government undertaking Board or Corporation or Local Bodies or Limited company established under the Companies Act, 2013 which can be considered equivalent to the post not below the rank of Superintendent of District Jail, in the Gujarat Jail Service, Class II in the Jail Department;
 - (c) have fulfill the requisite criteria of physical standards as prescribed in Appendix "A" annexed to this rules;
 - (d) possess the basic knowledge of computer application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967;
 - (e) have passed the physical efficiency test as may be prescribed by the Government;
 - (f) possess adequate knowledge of Gujarat or Hindi or both.
 4. A candidate appointed by direct selection shall be on probation for a period of two years:

Provided that the appointing authority may, if it think fit in any case, extend the period of probation for a further period not exceeding two years.
 5. The candidate appointed by direct selection shall, during his probation period, require to undergo pre-service training and to pass the post-training examination in accordance with the provisions of the Gazetted Officers Pre-Service Training and Examination Rules, 1970.
 6. The candidate appointed by direct selection shall, during his probation period, require to pass the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006.
 7. The candidate appointed by direct selection shall require to pass an examination in Hindi or Gujarati or both in accordance with the rules prescribed by the Government.

8. A candidate appointed either by promotion or by direct selection shall require to undergo such training and to pass such examination as may be prescribed by the Government.
9. A candidate appointed by direct selection shall require to furnish a security and a surety bond in such form, for such amount and for such period as may be prescribed by the Government.

Appendix 'A'

Minimum physical standards for the post of *Superintendent, Central Prison and Superintendent, Porbandar Special Prisons, Class I*

Norms to be taken in to consideration by Medical Officer.

Physical Standards:-

A. All Male candidates shall be physically fit as per the standards for different classes of person as specified below:

Class	Height	Chest		Weight
		Deflated	Inflated*	
Scheduled Tribe Candidate of Gujarat Origin.	160 Centimeters.	84 Centimeters.	89 Centimeters.	50 kilogram.
Candidates except Scheduled Tribe of Gujarat Origin.	165 Centimeters.	84 Centimeters.	89 Centimeters.	50 kilogram.

* Minimum expansion of chest when inflated shall not be less than 5 centimeters.

B. All Female candidates shall be physically fit as per the standards for different classes of person as specified below:

Class	Height	Weight
Scheduled Tribe Candidate of Gujarat Origin.	156 Centimeters.	45 kilogram.
Candidates except Scheduled Tribe of Gujarat Origin.	158 Centimeters.	45 kilogram.

1. The Candidate having any of the following physical defects shall not be fit for the post, namely :-
 - (i) Knock Knee, (ii) pigeon chest, (iii) squint eye, (iv) flat feet, (v) varicose veins, (vi) hammer Toes, (vii) fractured Limb, (viii) decayed teeth, (ix) communicable, or (x) skin disease.

2. The Medical Officer shall, examine the candidate and issue the certificate of fitness taking into consideration the physical standards as mentioned above and also certify for the following matter, namely:-

SHAPEI Means	S	Psychological.
	H	Hearing.
	A	Appendage.
	P	Physical capacity for normal work.
	E	Eye sight.
	I	Mean fit in all respect to perform normal Professional functions under each or the above mentioned heads.

3. The candidate shall be free from surgical deformities like knock-knees, flat-foot and should not have a past history of fits or psychiatric ailments, varicose vein, etc.

Prision Act, 1894.

No. GG-76/2018/JLM/502008/4809/J:- In exercise of the powers conferred by sub-section (10) of section 59 read with section 6 of the Prisons Act, 1894 (9 of 1894), the Government of Gujarat hereby makes the following rules further to amend the Superintendent, Central Prison and Superintendent, Porbandar Special Prison, Class I, Recruitment Rules, 2016, namely:-

1. These rules may be called the Superintendent, Central Prison and Superintendent, Porbandar Special Prison, Class I, Recruitment (Amendment) Rules, 2018.
2. In the Superintendent, Central Prison and Superintendent, Porbandar Special Prison, Class I, Recruitment Rules, 2016 (hereinafter referred to as "the said rules"), in rule 3, in clause (a), in the first proviso, for the word "Economically", the word "Educationally" shall be substituted.
3. In the said rules, after rule 9, the following rule shall be added, namely:-

"10. Where in respect of any matter regarding service conditions of the Superintendent, Central Prison and Superintendent, Porbandar Special Prison, in the Gujarat Jail Service, Class I, in the Jail Department for which specific provision is not made either in the Prisons Act, 1894 or in these rules, the following rules as amended from time to

time which are applicable to the employees of the corresponding class of Government of Gujarat, shall, *mutatis-Mutandis*, apply to the Superintendent, Central Prison and Superintendent, Porbandar Special Prison in the Gujarat Jail Service, Class I, in the Jail Department, whom these rules are applicable, namely:-

- (a) The Gujarat Civil Services Classification and Recruitment (General) Rules, 1967;
- (b) The Gujarat Civil Services (Pay) Rules, 2002;
- (c) The Gujarat Civil Services (Additions to Pay) Rules, 2002;
- (d) The Gujarat Civil Services (General Conditions of Service) Rules, 2002;
- (e) The Gujarat Civil Services (Travelling Allowance) Rules, 2002;
- (f) The Gujarat Civil Services (Occupation of Government Residential Accommodation) Rules, 2002;
- (g) The Gujarat Civil Services (Leave) Rules, 2002; and
- (h) The Gujarat Civil Services (Pension) Rules, 2002."
