## CORRIGENDUM

### Advertisement No. 40/2018-19 (Final Result)

No.: CCE-2018-711-(16)-EX

1. The Final result for the recruitment to the various posts in G.A.S., Class-I, Gujarat Civil Services, Class-I & II and Gujarat Municipal Chief Officer Service, Class-II, Advt. No. 40/2018-19 for which written test held on 17<sup>th</sup> & 24<sup>th</sup> February & 3<sup>rd</sup> March, 2019 and personal interview test held during 10<sup>th</sup> to 28<sup>th</sup> June, 2019 held from 10<sup>th</sup> June to 28<sup>th</sup> June, 2019 was declared by the Commission on 4<sup>th</sup> July, 2019 vide Notification No:- CCE-2018-711-(16)-EX.
2. It has been brought to the notice of the Commission that in the process of indicative allotment of various cadre posts to the S.C. category candidates, there was mistake in the indicative allotment of cadre post to the S.C. category candidates shown at Merit Nos. 141, 143, 181, 183, 194, 198 and 203.
3. Accordingly, subsequent to the revision carried out, inter-se indicative allotment of posts stands changed. The significant resultant modifications in Annexure-1, Part-I "List of Candidates to be Recommended to the Government for Appointment" and Part-II "List of Unsuccessful Candidates" of the Notification No:-CCE-2018-711-(16)-EX is mentioned as under
4. **Subsequent to the revision:-**
  - (I) The posts are re-allocated to the candidates are shown as below :-

(II) Subsequent to the above re-allocation process, 02 candidates belonging to S.C. Category, at Merit Nos. 143 and 183, who were earlier considered as MRC candidates, now are considered as S.C. category candidates, as they get better preference posts.

(III) Consequently, the entry of S.C. category candidates declared successful in the result published earlier, at Merit Nos. 227 and 231 in Part-I of Annexure-I is deleted from the list of candidates to be recommended to the Government for appointment and these candidates are declared unsuccessful.

(IV) As a result of this, 02 candidates, next in order of merit, who were declared unsuccessful at Sr. Nos. 43 and 554 in Part-II of Annexure-I are now declared successful. Entry of these Candidates is inserted at Merit Nos. 186-A and 186-B, respectively with details as below:
