Note :-

- (1) The S.C. Category candidates at Merit Nos. 07 (Female), 13 (Female) and the S.T. Category candidates at Merit Nos. 04, 17 (Female) and 19 (Female), are ***to be recommended for appointment on unreserved posts*** as per Government circular, GAD No. PVS-1099-MM-13-G4 dated 29-1-2000 and PVS-2010-03-900-G4, dated 23/07/2004, as they have not availed relaxation in Qualifying Standard in Preliminary Test or in age.
- (2) The S.C. Category candidate at Merit No. 14 and the S.T. Category candidates at Merit Nos. 09, 11, 15, 20, though secured their place in the merit of general category, however they are to be recommended for appointment against the posts reserved for their respective categories, as per Government circular, GAD No. PVS-1099-MM-13-G4 dated 29-1-2000 and PVS-2010-03-900-G4, dated 23/07/2004, as they have availed the benefit of relaxation in qualifying standard in the preliminary test.
- (3) 44 posts of SEBC, 07 posts of S.C., 16 posts of S.T., 57 posts of General category, 05 posts reserved for Disabled candidates and 01 post reserved for Ex-serviceman remains vacant.
- (4) **The Weighted Marks of Preliminary Test & Interview are calculated as follows :-** [Marks obtained in P.T. X 50/300 = Weighted Marks of Preliminary Test] + [Marks obtained in Interview X 50/100 = Weighted Marks of Interview] = Total Weighted Marks.
