## Constitution of India.

No. GYC/13/06/SHL/102006/902/A:— In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of **Curator Class II**, in the General State Service, under the Directorate of Museums, Gujarat State, namely:-

1. These rules may be called the **Curator, Class II**, Recruitment Rules, 2013.
2. Appointment to the post of **Curator, Class II** in the General State Service under the Directorate of Museums, Gujarat State, shall be made either,-

by promotion of a person of proved merit and efficiency from amongst the persons who,-

(i) have worked for not less than seven years in the cadre of **Assistant Curator, Class III**, in the subordinate service of the Directorate of Museums; and

(ii) have passed the qualifying examination for computer knowledge in accordance with the Provisions of the Gujarat Civil Services Computer Competency Training and Examination Rule, 2006:

Provided that where the appointing authority is satisfied that a person having the experience specified in sub clause (i) above is not available for promotion and that it is necessary in the public interest to fill up the post by promotion even of a person having experience for a lesser period; it may, for reasons to be recorded in writing, promote such person who possess experience of a period of not less than two thirds of the period specified in sub clause (i) above; or

- (b) by direct selection.

To be eligible for appointment by direct selection to the post mentioned in rule 2, a candidate shall,-

- (a) not be more than 35 years of age :

Provided that the upper age limit may be relaxed in favour of a candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967.

- (b) possess,-

(i) a second class post graduate degree obtained from any of the Universities established or incorporated by or under the Central or State Act in India; or any other educational institution recognized as such or declared to be deemed as University under section 3 of the University Grants Commission Act, 1956 or possess an equivalent qualification recognized by the Government, in one of the following subjects, namely :-

- (i) History (ii) Ancient Indian History and Culture (iii) Archaeology (iv) Fine Arts- Arts History (v) Painting (vi) Geology (vii) Zoology (viii) Anthropology (ix) Chemistry (x) Botany (xi) any Indian classical Language; and

(ii) a post-graduate Diploma or post graduate degree in Museology obtained from any of the Universities established or incorporated by or under the Central or State Act in India; or any other educational institution recognized as such or declared to be deemed as University under section 3 of the University Grants Commission Act, 1956; or possess an equivalent qualification recognized by the Government;

(c) (i) have about three years experience on the post not below the rank of Assistant curator Class III in subordinate service of Directorate of Museums ; or

(ii) have about three years experience in public sector museum or private museum on the post which can be treated equivalent to the post not below the rank of Assistant Curator, Class III, subordinate service of the Directorate of Museums;

(d) possess the basic knowledge of computer application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967;

(e) possess the adequate knowledge of Gujarati and/or Hindi or both.

4. A candidate appointed by direct selection shall be on probation for a period of two years.

A selected candidate shall be required to pass an examination in Hindi or Gujarati or both in accordance with the rules prescribed by the Government.

6. A candidate appointed by direct selection shall, during his probation period, be required to undergo Pre-Service training and pass the post training examination in accordance with the Gazetted Officer's Pre-service Training and Examination Rule, 1970.

7. A candidate appointed by direct selection shall, during his probation period, be required to pass the qualifying examination for computer knowledge in accordance with the Provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006.

8. A candidate appointed either by direct selection or by promotion shall have to undergo such training and pass such examination as may be prescribed by the Government.

9. A candidate appointed by direct selection shall be required to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by the Government.

**Constitution of India.** NO.GVC/09/2018/SHL/102006/902/A : In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Gujarat hereby makes the following rules further to amend the Curator, Class II, Recruitment Rules, 2013, namely:-

1. These rules may be called the Curator, Class II, Recruitment (Amendment) Rules, 2018.

2. In the Curator, Class II, Recruitment Rules, 2013, in rules 3, -

(i) for clause (a), the following clause shall be substituted, namely:-

“(a) not be more than 40 years of age :

Provided that the upper age limit may be relaxed in favour of a candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967:

Provided further that nothing contained in clause (b) of sub-rule(9) of rule 8 of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967 shall be applicable in so far as relaxation of upper age limit as prescribe above is concerned.”


(ii) For clause (b), the following clause shall be substituted, namely:-

“(b) possess,-

(i) a post graduate diploma in Museology obtained from any of the Universities established or incorporated by or under the Central or a State Act in India; or any other educational institution recognised as such or declared to be deemed as University under section 3 of the University Grants Commission Act, 1956; or

(ii) a second class post graduate degree in Museology obtained from any of the Universities established or incorporated by or under the Central or a State Act in India; or any other educational institution recognised as such or declared to be deemed as University under section 3 of University Grants Commission Act, 1956; or possess an equivalent qualification recognised by the Government.”

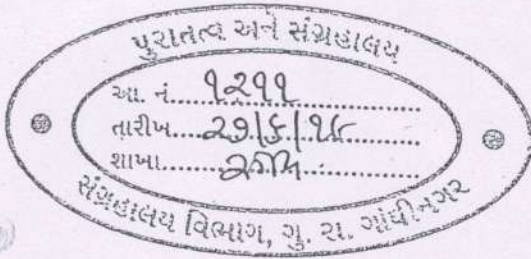
