1 Final Result for the posts of **Principal, Gujarat Skill Training Service, Class-II, Advt. No.44/2018-19** was published on **11th June, 2019**. The results of the 02 petitioners of S.C.A. No. 9789 of 2019 and S.C.A. No. 9790 of 2019, who were called for interview conditionally, were kept in 02 separate "Sealed Covers", as per the Hon'ble High Court's oral order dated 27/05/2019.

2 As per the direction given by the Hon'ble High Court in common oral Judgement dated 02/12/2022 in SCA Nos. 9789 and 9790 of 2019, the petitioners are to be placed in the select / waiting list at appropriate place.

3 In view of the above, the Commission has, vide its decision dated 31/12/2022, decided to modify the result dated 11th June, 2019. Hence, Waiting List for SEBC category is modified as under:

(a) The petitioner Shri Ronak Kalidas Barot (bearing E. No. 177) has obtained 42.79 Marks. The Cut-off Marks of SEBC Category is 43.13 Marks. As Shri Barot has obtained less Marks than the Cut-off Marks of SEBC Category but has obtained more marks than the candidate kept at Serial No. 02 of the Waiting List for SEBC category (i.e. 42.16) in the original result published on 11th June, 2019, he is now kept at serial No. 1A after the serial No. 1 of the Waiting List for SEBC category, on the basis of the aggregate marks obtained by him.

(b) The petitioner Shri Yogesh Narotam Kateshiya, bearing E. No. 176 has obtained 42.60 Marks. The Cut-off Marks of SEBC Category is 43.13 Marks. As Shri Kateshiya has obtained less Marks than the Cut-off Marks of SEBC Category but has obtained more marks than the candidate kept at Serial No. 02 of the waiting List for SEBC category (i.e. 42.16) in the original result published on 11th June, 2019, he is now kept at serial No. 1B after the serial No. 1A of the Waiting List for SEBC category, on the basis of the aggregate marks obtained by him.
