No..... :- In exercise of the powers conferred by the sub section (3) of section 457 of the Gujarat Provincial Municipal Corporation Act, 1949 and insupercession of all the rules made in this behalf, the Gandhinagar Municipal Corporation hereby makes the following rules to provide for regulating recruitment to the post of Health Officer, class II, in the Gandhinagar Municipal Corporation, namely:-


1. (a) These rules may be called the Health Officer, class II, in the Gandhinagar Municipal Corporation Recruitment Rules 2017.
(b) They shall come into force at once.
2. Appointment to the post of Health Officer, class II, in the Gandhinagar Municipal Corporation shall be made either:-
 - (a) by direct selection, or
 - (b) by temporary transfer on deputation basis from amongst the persons working on the cadre of Medical Officer, Class-II, in Government Department who possess the educational qualification as prescribed in..... sub rule (b) of rule 3 of these rules.
3. To be eligible for appointment by direct selection to the post mentioned in rule - 2, a candidate shall -
 - (a) not be less than 18 years and not be more than 40 years of age;

Provided that the upper age limit may be relaxed in favour of a candidate belonging to Scheduled Castes or Scheduled Tribes or Socially and Educationally Backward Classes or Economically Weaker Sections or Women in accordance with the provisions of the sub rule (2) of rule 8 of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967.

- (b) possess
- (i) a degree of Bachelor of Medicine and Bachelor of Surgery (M.B.B.S.) of any of the Universities established or incorporated by or under the Central or State Act in India or any other educational institution recognized as such or declared to be a deemed university under section 3 of the University Grants Commission Act, 1956 or possess any other qualification specified in first or second schedule to the Indian Medical Council Act, 1956, and
 - (ii) a post graduate degree or diploma in Public Health of any of the Universities established or incorporated by or under the Central or State Act in India or any other educational institution recognized as such or declared to be a deemed university under section 3 of the University Grants Commission Act, 1956,
- (c) possess the basic knowledge of computer application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967, and
- (d) possess adequate knowledge of Gujarati or Hindi or both.
4. A candidate appointed by direct selection shall be on probation for a period of two years.
5. A candidate appointed by direct selection shall during his probation period, be required to pass the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency (Training and Examination) Rules, 2006 or the examination for computer knowledge as may be prescribed by the Gandhinagar Municipal Corporation.
6. A candidate appointed by direct selection will be required to pass an examination in Hindi or Gujarati or both in accordance with the rules prescribed by the Gandhinagar Municipal Corporation.

7. A candidate appointed by direct selection shall be required to get himself registered under the Gujarat Medical Council Act, 1967 at the time of his/her application for direct selection, if he is not so register.
8. A candidate appointed by direct selection shall have to undergo such training and to pass such examination as may be prescribed by the Gandhinagar Municipal Corporation.
9. A candidate appointed by direct selection will be required to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by the Gandhinagar Municipal Corporation.

No. COMC/MKM/F.N.148/R.R./12857/20 :- In exercise of the powers conferred by the sub section (3) of section 457 of the Gujarat Provincial Municipal Corporation Act, 1949, the Gandhinagar Municipal Corporation hereby makes the following rules further to amend the Health Officer, class II, in the Gandhinagar Municipal Corporation Recruitment Rules, 2017, namely:-

1. These rules may be called the Health Officer, class II, in the Gandhinagar Municipal Corporation Recruitment (Amendment) Rules, 2020.
2. In the Health Officer, class II, in the Gandhinagar Municipal Corporation Recruitment Rules, 2017, in rule 3, for clause (b), the following shall be substituted,

“(b) possess a degree of Bachelor of Medicine and Bachelor of Surgery (M.B.B.S.) of any of the Universities established or incorporated by or under the Central or State Act in India or any other educational institution recognized as such or declared to be a deemed university under section 3 of the University Grants Commission Act, 1956 or possess any other qualification specified in first or second schedule to the Indian Medical Council Act, 1956,”
