CONSTITUTION OF INDIA.

No.: -GJ/ 9 of 2015/RRC/102014/1764/E-5 :- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of Assistant Engineer (Civil), Class-II, in the Gujarat Engineering Services under the Narmada, Water Resources, Water Supply and Kalpasar Department, namely :-

1. These rules may be called the Assistant Engineer (Civil), Class-II, Recruitment Rules, 2015.
2. Appointment to the post of Assistant Engineer (Civil), Class-II, in the Gujarat Engineering Services, under the Narmada, Water Resources, Water Supply and Kalpasar Department shall be made by direct selection on the basis of the result of the competitive examination, held by the Gujarat Public Service Commission for this purpose.
3. To be eligible for appointment by direct selection to the post mentioned in rule-2, a candidate shall,-
 - (a) not be more than 30 years of age :

Provided that the upper age limit may be relaxed in favour of a candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967.

(b) possess,-

- (i) a degree in Engineering (Civil) obtained from any of the Universities or institutions established or incorporated by or under the Central or State Act in India; or any other educational institutions recognised as such or declared to be a deemed University under section 3 of the University Grants Commission Act, 1956.

- (ii) the basic knowledge of computer application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967.
 - (iii) adequate knowledge of Gujarati or Hindi or both.
4. The selected candidate shall be on probation for a period of two years.
 5. The selected candidate shall, during his probation period, be required to pass the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006.
 6. The selected candidate shall require to pass the departmental/ professional examination and an examination in Hindi or Gujarati or both in accordance with the rules prescribed by the Government.
 7. The selected candidate shall have to undergo such training and pass such examination as may be prescribed by the Government.
 8. The selected candidate shall be required to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by the Government.

No. GJ / 07 of 2016/ RRC/102014/1764/E-5:- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Gujarat hereby makes the following rules further to amend the Assistant Engineer (Civil), Class II, Recruitment Rules 2015, namely:-

1. These rules may be called the Assistant Engineer (Civil), Class II, Recruitment (Amendment) Rules, 2016.
2. In the Assistant Engineer (Civil), Class II, Recruitment Rules, 2015, (hereinafter referred to as "the said rules") in rule 2, the words, "on the basis of the result of the competitive examination, held by the Gujarat Public Service Commission for this purpose" shall be deleted.
3. In the said rules, in rule 3, in clause (a), for the figures and word "30 years", the figures and word "35 years" shall be substituted.
4. In the said rules, in rule 4 to 8 for the words "The selected candidate" wherever it occurs, the word "The candidate appointed by direct selection" shall be substituted.
