OF INDIA.

NO. GJ/2/2016/EST/122010/972/G: -in exercise of the powers conferred by the proviso to article 309 of the constitution of India and in supersession of all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of Manager Grade I, class II, in the General State Service under the Roads and Building Department, namely:-

- 1. These rules may be called the Manager Grade I class II , in the Roads and Buildings Department Recruitment Rules, 2016.**
- 2. Appointment to the post of Manager Grade I, Class II, in the General State Service under the Roads and Buildings Department shall be made either,-**
 - (a) by promotion of a person of proved merit and efficiency from amongst the persons who,-**
 - (i) have worked for not less than seven years in the cadre of Manager Grade II, class III in the subordinate service of the Roads and Buildings Department and;**
 - (ii) have passed the qualifying examination for computer Knowledge in accordance with the provisions of the Gujarat Civil Services Computer competency Training and Examination Rules, 2006 :**

Provided that where the appointing authority is satisfied that a person having the experience specified in sub-clause (i) above is not available for promotion and that it is necessary in the public interest to fill up the post by promotion even of a person having experience for a lesser period; it may, for reasons to be recorded in writing promote such person who possesses experience of a period of not less than two-thirds of the period specified in sub-clause (i) above; or
 - (b) by direct selection .**

3. Appointments by direct selection and promotion shall be made in the ratio of 1: 2.
4. To be eligible for appointment by direct selection to the post mentioned in rule 2, a candidate shall,-

(a) not be more than 35 years of age :

Provided that upper age limit may be relaxed in favor of a candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Service Classification and Recruitment (General) Rules, 1967:

Provided further that nothing contained in clause (b) of sub-rule (9) of rule 8 of the Gujarat Civil Services Classification and Recruitment Rules, 1967 shall be applicable in so far as relaxation of upper age limit as prescribed above is concern.

(b) possess,-

(i) a Degree in Hotel Management and catering obtained from National council of Hotel Management or obtained from any of the Universities established or incorporated by or under the Central or a State Act in India; or any other educational institution recognized as such or declared to be deemed as University under section 3 of the University Grants Commission Act, 1956; or possess an equivalent qualification recognized as such by the Government; or

(ii) a Diploma in Hotel Management and/or Catering Technology obtained from any recognized institute or obtained from any of the Universities established or incorporated by or under the Central or a State Act in India; or any other educational institution recognized as such or declared to be deemed as University under section 3 of the University Grants Commission Act, 1956; or possess an equivalent qualification recognized as such by the Government and

(a) have about two years experience on the post not below the rank of Manager Grade II, class III in the subordinate service of the Roads and Buildings Department; or


- (b) have about two years experience in the field of Hotel Management or catering in Government or Local Bodies or Government under taking Board or Corporation or Limited Company established under the companies Act, 2013 or the private or public sector hotels ranking in two star or more on the post which can be considered equivalent to the post not below the rank of Manager Grade II, class III in the subordinate service of the Roads and Buildings Department;
- (c) Possess the basic knowledge of computer application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967; and
- (d) Possess adequate knowledge of Gujarati or Hindi or both.

5. The candidate appointed by direct selection shall be on probation for a period of two years.
6. The candidate appointed by direct selection shall, during his probation period, require to undergo pre-service training and pass the post training examination in accordance with the provisions of the Gazetted officer's (Pre-service Training and Examination) Rules, 1970.
7. The candidate appointed by direct selection shall, during his probation period, require to pass the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer competency Training and Examination Rules, 2006.
8. The candidate appointed by direct selection shall require to pass an examination in Gujarati or Hindi or both in accordance with the rules prescribed by the Government.
9. The candidate appointed either by promotion or by direct selection shall have to undergo such training and pass such examination as may be prescribed by the Government.

- (b) have about two years experience in the field of Hotel Management or catering in Government or Local Bodies or Government under taking Board or Corporation or Limited Company established under the companies Act, 2013 or the private or public sector hotels ranking in two star or more on the post which can be considered equivalent to the post not below the rank of Manager Grade II, class III in the subordinate service of the Roads and Buildings Department ;
 - (c) Possess the basic knowledge of computer application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967; and
 - (d) Possess adequate knowledge of Gujarati or Hindi or both.
5. The candidate appointed by direct selection shall be on probation for a period of two years.
 6. The candidate appointed by direct selection shall, during his probation period, require to undergo pre-service training and pass the post training examination in accordance with the provisions of the Gazetted officer's (Pre-service Training and Examination) Rules, 1970.
 7. The candidate appointed by direct selection shall, during his probation period, require to pass the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer competency Training and Examination Rules, 2006.
 8. The candidate appointed by direct selection shall require to pass an examination in Gujarati or Hindi or both in accordance with the rules prescribed by the Government.
 9. The candidate appointed either by promotion or by direct selection shall have to undergo such training and pass such examination as may be prescribed by the Government.

- 10. The candidate appointed by the direct selection shall be required to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by the Government.
