NOTIFICATION

Sachivalaya, Gandhinagar, 30th July, 2015

No. GU/2015/37/BRT/102008/698/D2 :- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of Assistant Manager, Class II, in the General State Service, under the Directorate of Government Printing and Stationery, Gujarat State, namely :-

1. These rules may be called the Assistant Manager, Class II, Recruitment Rules, 2015.
2. Appointment to the post of Assistant Manager, Class II, in the General State Service under the Directorate of Government Printing and Stationery, Gujarat State shall be made either,
 - (a) by promotion of a person of proved merit and efficiency from amongst the persons who:-
 - (i) have worked for not less than seven years in the cadre of Machine Overseer or Binding Overseer or Standard Overseer or Head Examiner or Senior Estimator, Class III, in the subordinate service of the Directorate of Government Printing and Stationery Gujarat State;
 - (ii) have passed the prescribed departmental examination; and
 - (iii) have passed the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006 :

Provided that where the appointing authority is satisfied that a person having the experience specified in sub-clause (i) above is not available for promotion and that it is necessary in the public interest to fill up the post by promotion even of a person having experience for a lesser period, it may, for reasons to be recorded in writing, promote such person who possesses experience of a period of not less than two-thirds of the period specified in sub clause (i) above; or

(b) by direct selection,

3. The appointment made by promotion and by direct selection shall be made in the ratio of 1:1 respectively.

4. To be eligible for appointment by direct selection to the post mentioned in rule 2, a candidate shall,
 - (a) not be more than 32 years of age :

Provided that the upper age limit may be relaxed in favour of a candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967;

(b) (i) possess a degree in Printing Technology obtained from any of the Universities established or incorporated by or under the Central or a State Act in India; or any other educational institutions recognised as such or declared to be deemed as University under section 3 of the University Grants Commission Act, 1956; and

(A) have about two years experience on the post not below the rank of Machine Overseer or Binding Overseer or Standard Overseer or Head Examiner or Senior Estimator, Class III, in the subordinate service of the Directorate of Government Printing and Stationery, Gujarat State; or

(B) have about two years separate or combined experience in modern composing or printing or binding system or industrial cost accounting and estimating related to printing industries. Such experience shall be gained in the printing press having at least two offset printing machine and other printing machinery on the post which can be considered equivalent to the post not below the rank of Machine Overseer or Binding Overseer or Standard Overseer or Senior Estimator or Head Examiner, Class III, in the subordinate service of the Directorate of Government Printing and Stationery, Gujarat State; or

(ii) possess a diploma in Printing Technology obtained from any of the Universities established or incorporated by or under the Central or State Act in India; or any other educational institutions recognised as such or declared to be deemed as University under section 3 of the University Grants Commission Act, 1956; and

(A) have about four years experience on the post not below the rank of Machine Overseer or Binding Overseer or Standard Overseer or Head Examiner or Senior Estimator, Class III, in the subordinate service of the Directorate of Government Printing and Stationery, Gujarat State; or

(B) have about four years separate or combined experience in modern composing or printing or binding system or industrial cost accounting and estimating related to printing industries. Such experience shall be gained in the printing press having at least two offset printing machine and other printing machinery on the post which can be considered equivalent to the post not below the rank of Machine Overseer or Binding Overseer or Standard Overseer or Senior Estimator or Head Examiner, Class III, in the subordinate service of the Directorate of Government Printing and Stationery, Gujarat State;

(C) possess basic knowledge of computer application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967; and

(D) possess adequate knowledge of Gujarati or Hindi or both.

5. The candidate appointed by direct selection shall be on probation for a period of two years.
6. The candidate appointed by direct selection shall, during his probation period, require to undergo pre-service training and to pass the post-training examination in accordance with the provisions of the Gazetted Officer's (Pre-service Training and Examination) Rules, 1970.
7. The candidate appointed by direct selection shall, during his probation period require to pass the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006.
8. The candidate appointed by direct selection shall require to pass the departmental examination and an examination in Hindi or Gujarati or both in accordance with the rules prescribed by the Government.
9. A candidate appointed either by direct selection or by promotion shall have to undergo such training and pass such examination as may be prescribed by the Government.
10. The candidate appointed by direct selection shall be required to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by the Government.

1. These rules may be called the Assistant Manager, Class II, Recruitment (Amendment) Rules, 2016.
2. In the Assistant Manager, Class II, Recruitment Rules, 2015, (herein after referred to as "the said rules"), for rule 1 the following rule shall be substituted, namely:-

"1. These rules may be called the Assistant Manager, Class II, in the Directorate of Government Printing and Stationary Recruitment Rules, 2015"

3. In the said rules, in rule 4, in clause (a),-

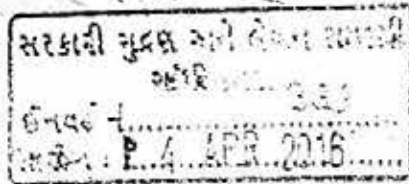
- (i) for the figures and word "32 years", the figures and word "37 years" shall be substituted.
- (ii) after the existing proviso, the following proviso shall be inserted, namely :-

"Provided further, that nothing contained in clause (b) of sub rule(9) of rule 8 of the Gujarat Civil Services Classification and Recruitment(General), Rules, 1967 shall be applicable in so far as relaxation of upper age limit as prescribed above is concerned;"

1. These rules may be called the Assistant Manager, Class II Recruitment (Amendment) Rules, 2020.
2. In the Assistant Manager, Class II, Recruitment Rules, 2015, (hereinafter referred to as "the said rules"), in rule 2 in clause (a), for the words "of proved merit and efficiency" the words, brackets and figures "who possess 'good' benchmark for being considered fit for promotion within the Zone of consideration as laid down in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967", shall be substituted.
3. In the said rules, in rule 4, in clause (b), (i) in sub-clause (i), for the words "possess a degree", the words "possess a bachelor's degree" shall be substituted, (ii) in sub-clause (ii), after the words "obtained from" the words "Technical Examinations Board or" shall be inserted.
