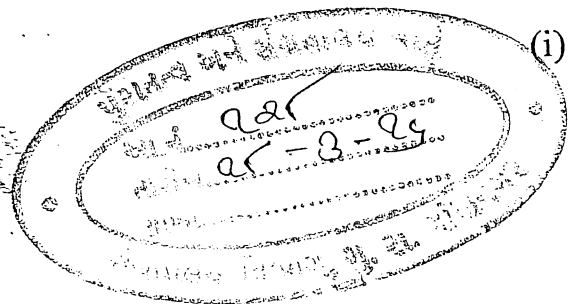

No.GYC/3/2016/NPS/102014/1008/A :- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, and in supersession of all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of Director of Archaeology and Museums, Class I, in the General State Service, Gujarat State, namely:-

1. These rules may be called the Director of Archaeology and Museums, Class-I, Recruitment Rules, 2016.
2. Appointment to the post of Director of Archaeology and Museums, Class I, shall be made, either,-
 - (a) by promotion of a person who possess "very good bench mark" for being considered fit for promotion as laid down in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967 from amongst the persons, who,-
 - (i) have worked for not less than five years in the cadre of Deputy Director Archaeology and Museums, Class I, under the Directorate of Archaeology and Museums Gujarat State; and

- (ii) have passed the qualifying examination for computer knowledge in accordance with the provisions of the



Gujarat Civil Services Computer Competency

Training and Examination Rules, 2006:

Provided that where the appointing authority is satisfied that a person having the experience specified in sub-clause (i) above is not available for promotion and that it is necessary in the public interest to fill up the post by promotion even of a person having experience for a lesser period; it may, for reasons to be recorded in writing, promote such person who possesses experience of a period of not less than two-thirds of the period specified in sub-clause (i) above; or
(b) by direct selection.

3. To be eligible for appointment by direct selection to the post mentioned in rule 2, a candidate shall-

(A) not be more than 45 years of age:

Provided that the upper age limit may be relaxed in favour of a candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967;

Provided further that nothing contained in clause (b) of sub-rule (9) of rule 8 of the Gujarat Civil Services, Classification and Recruitment (General) Rules, 1967 shall be applicable in so far as relaxation of upper age limit as prescribed above is concerned.

(B) possess,-

(i) a Ph.D or second class post-graduate degree in Archaeology; or

(ii) a Ph.D or second class post graduate degree in Museology; or

(iii) (a) second class post-graduate degree in any one of the following subjects, namely :-

“History or Geology or Zoology or Anthropology or Ethnology or Sanskrit or Arabic;” and

(b) a post graduate Diploma in Archaeology or Museology obtained from any of the Universities established or incorporated by or under the Central or a State Act in India; or any other educational institution recognised as such or declared to be deemed as University under section 3 of the University Grants Commission Act, 1956;

(C) possess the basic knowledge of computer application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967;

(D) (i) have about ten years experience on the post not below the rank of Assistant Director(Archaeology), Class II or Assistant Director (Museums), Class II or Assistant Director (Archaeology and Museums), Class II

in the General State Service, under the Directorate of Archaeology and Museums Gujarat State, or


(ii) have about ten years experience in the field of Archaeological work such as Exploration and/or Excavation or organization of Government Museum or Public Sector Museum or Private Museum on the post which can be considered equivalent to the post not below the rank of Assistant Director (Archaeology), Class II or Assistant Director (Museums), Class II or Assistant Director (Archaeology and Museums), Class II in the General State Service, under the Directorate of Archaeology and Museums, Gujarat State,

(E) possess adequate knowledge of Gujarati or Hindi or both.

4. The candidate appointed by direct selection shall be on probation for a period of two years.
5. The candidate appointed by direct selection shall during his probation period require to undergo pre-service training and pass the post-training examination in accordance with the provisions of the Gazetted Officer's Pre-service Training and Examination Rules, 1970.

6. The candidate appointed by direct selection shall during his probation period require to pass the qualifying examination for computer knowledge in accordance with provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006.
 7. The candidate appointed by direct selection shall require to pass an examination in Hindi or Gujarati or both in accordance with the rules as may be prescribed by the Government.
 8. The candidate appointed either by promotion or by direct selection shall require to undergo such training and pass such examination as may be prescribed by the Government.
 9. The candidate appointed by direct selection shall require to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by the Government.
