No. GHKH/69/2018/BGM/2016/18/K.8:- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of Deputy Director of Horticulture, class I, in the Gujarat Horticulture Service, under the Directorate of Horticulture, namely :-

1. These rules may be called the Deputy Director of Horticulture, Class I, in the Gujarat Horticulture Service, under the Directorate of Horticulture Recruitment Rules, 2018.
2. Appointment to the post of Deputy Director of Horticulture, Class I, in the Gujarat Horticulture Service, under the Directorate of Horticulture shall be made either,-
  - (a) by promotion of a person of proved merit and efficiency from amongst the persons who,
    - (i) have worked for not less than eight years in the cadre of Assistant Director of Horticulture/Subject Matter Specialist, Class-II, in the Gujarat Horticulture Service ; and
    - (ii) have passed the departmental examination for promotion to the post of Deputy Director of Horticulture as may be prescribed by the Government; and
    - (iii) have passed the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules 2006 :

Provided that where the appointing authority is satisfied that a person having the experience specified in sub-clause (i) above is not available for promotion and it is necessary in public interest to fill up the post by promotion even of a person having experience for a lesser period; it may, for reasons to be recorded in writing, promote such person who possesses experience of a period of not

less than two thirds of the period as specified in sub-clause (i) above; or

(b) by direct selection.

3. The appointment by direct selection and promotion shall be made in the ratio of 1:2 respectively.

4. To be eligible for appointment by direct selection to the post mentioned in rule 2, the candidate shall,-

(A) not be more than 42 years of age;

Provided that the upper age limit may be relaxed in favor of a candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967:


Provided further that nothing contained in clause (b) of sub-rule (9) of rule 8 of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967 shall be applicable in so far as relaxation of upper age limit as prescribed above is concerned.

(B) Possess,-

(a) A Ph.D degree in any branch of Horticulture obtained from any of the Agriculture / Horticulture Universities incorporated or established by or under the Central or a State Act in India; or any other educational institution recognised as such or declared to be deemed as a University under section 3 of the University Grants Commission Act, 1956; and

(i) have about three years' experience on the post not below the rank of Horticulture Officer, Class II, in the Gujarat Horticulture service under the Directorate of Horticulture;

(ii) have about three years' Separate or Combined experience in the field of Horticulture Research / Horticultural Extension Service / Horticulture Education / Horticulture Engineering in Government / Government Undertaking Board / Corporation / Local bodies / Government recognised university / Government Research Institute / Limited Company established under the companies Act, 2013 / University on the post which can be considered equivalent to the post not below the rank of Horticulture Officer, Class II, in the Gujarat Horticulture Service under the Directorate of Horticulture ; or

(b) At least a second class Post Graduate degree in any branch of Horticulture obtained from any of the Agriculture Universities incorporated or established by or under the Central or a State Act in India; or other educational institution recognised as such or declared to be deemed as a university under section 3 of the University Grants Commission Act, 1956; and:

(i) have about five years' experience on the post not below the rank of Horticulture Officer, Class II, in the Gujarat Horticulture service under the Directorate of Horticulture; or

(ii) have about five years' Separate or Combined experience in the field of Horticulture Research / Horticultural Extension Service / Horticulture Education / Horticulture Engineering in Government / Government Undertaking Board / Corporation / Local bodies / Government recognised University / Government



- (c) the basic knowledge of computer application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967.
- (d) adequate knowledge of Gujarati or Hindi or both:
5. The candidate appointed by direct selection shall be on probation for a period of two years.
  6. The candidate appointed by direct selection during his probation period shall be required to pass the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006.
  7. The candidate appointed by direct selection during his probation period shall be required to undergo Pre-service training and pass the post-training examination in accordance with the provisions of the Gazetted Officer's PreService Training and Examination Rules, 1970.
  8. The candidate appointed by direct selection shall be required to pass the departmental examination, prescribed under the Gujarat Agriculture Department (Conditions of Service relating to Gazetted posts in Gujarat Horticulture Service in Class I and Class II Officers' Examination), Rules, 2004.
  9. The candidate appointed by direct selection shall be required to pass the examination in Gujarati or Hindi or both in accordance with the rules prescribed by the Government.
  10. The candidate appointed either by promotion or by direct selection shall be required to undergo such training and pass such examination as may be prescribed by the Government.

11. The candidate appointed by direct selection shall be required to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by the Government.





No. GHKH/40/2019/BGM/2016/18/K.8:- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Gujarat hereby makes the following rules further to amend the Deputy Director of Horticulture, Class I, in the Gujarat Horticulture Service, under the Directorate of Horticulture Recruitment Rules, 2018, namely :-

1. These rules may be called the Deputy Director of Horticulture, Class I, in the Gujarat Horticulture Service, under the Directorate of Horticulture Recruitment (Amendment) Rules, 2019.
2. In the Deputy Director of Horticulture, Class I, in the Gujarat Horticulture Service, under the Directorate of Horticulture Recruitment Rules, 2018, in rule 4, in clause (B),-

(1) for sub-clause (a), the following clause shall be substituted, namely:-

“(a) A Ph.D degree in any branch of Horticulture obtained from any of the Agriculture/Horticulture Universities incorporated or established by or under the Central Agriculture/Horticulture Universities Act or a State Agriculture/Horticulture Universities Act in India; and

(i) have about three years' experience on the post not below the rank of Horticulture Officer, Class II, in the Gujarat Horticulture service under the Directorate of Horticulture; or

(ii) have about three years' separate or combined experience in the field of Horticulture Research/ Horticultural Extension Service/ Horticulture Education/ Horticulture Engineering in the Government/ Government Undertaking/ Board/ Corporation/ Local bodies/ Government recognized University/ Government Research Institute/ Limited Company established under the Companies Act, 2013/ University/ Krishi Vigyan Kendra falling under the jurisdiction of Agriculture Technology Research Institutions of the Indian Council of Agriculture Research on the post which can be considered equivalent to the post not below the rank of Horticulture Officer, Class II, in the Gujarat Horticulture Service under the Directorate of Horticulture; or”

(2) for sub-clause (b), the following clause shall be substituted, namely:-

“(b) At least a second class post graduate degree in any branch of Horticulture obtained from any of the Agriculture/Horticulture Universities incorporated or established by or under the Central Agriculture/Horticulture Universities Act or State Agriculture/Horticulture Universities Act in India; and

(i) have about five years' experience on the post not below the rank of Horticulture Officer, Class II, in the Gujarat Horticulture service under the Directorate of Horticulture; or

(ii) have about five years' separate or combined experience in the field of Horticulture Research/ Horticultural Extension Service/ Horticulture Education/ Horticulture Engineering in the Government/ Government Undertaking/ Board/ Corporation/ Local bodies/ Government recognized
