  - A. Candidate who desires to have his marks in the Main Examination rechecked may apply to the Commission along with such fees as fixed by the Commission for each paper **within a period of 30 days from** the date of declaration of the final result of the Main Examination i.e. subsequent to Viva-voce.
  - B. Candidate who desires to have the Mark-sheet of the Main Examination or part thereof shall apply to the Commission along with such fees as may be fixed by the Commission **within a period of 15 days from** the date of declaration of the final result of the Main Examination i.e. subsequent to Viva-voce.
