1. Museology

Definition and concept of museum, eco-museum, community museum, virtual museum, neighbourhood museum; Definition and concept of museology and museography, History of development of museums in the world with special reference to India; Function and Role of museums; Classification and types of museums; Collection-policies, ethics and procedures; Collection management and documentation; Museum education and Communication; Museum Research and Publications; Museum and Public Relation, Theory of new Museology.

2. Art and Culture of India

Fundamentals of Art and Aesthetics; Land marks of Indian Art; Terracotta and Pottery; Study of coins; Study of Script and epigraphs; Decorative Arts of India (Metal, ivory, jewellery / ornaments); Ethnic art and traditional knowledge; Types of Painting, Sculpture and Architecture of India, Evolution of Indian Art, Tangible and Intangible Heritage.

3. Museum Architecture

Concept and development of museum architectural types; planning a new building, selection of a site, architectural considerations, like space, climate, need, fund, selection of Architect, construction, supervision, completion etc.; Adaption of old building; General principles and guidelines for conservation and preservation of old buildings.

4. Care and Conservation

Conservation of Antiquities and Art objects, paper, manuscripts, books and paintings; Understanding conservation, preservation and restoration; Ethics of conservation; Causes of deterioration; Significance and effectiveness of Preventive Conservation; Documentation procedures in laboratory; photo-documentation etc.; Instrument and Equipments used in conservation laboratory.

5. Chemical preservation of museum collection and exhibits

Ethics of conservation, preservation and restoration and its history; Basic chemistry. Causes of decay of museum objects – Metallic objects (Gold, Silver, Copper, Bronze, Lead, Iron), objects made of organic materials (Ivory, Bone, Horn, Leather, Parchment, Furs, Paper, Birch bark, Palm Leaf, Wood and Textile), Siliceous, Calcareous and Argillaceous materials (Stone, Semi-Precious Stone, Mineral, Mud, Terracotta, Ceramics, Glass, Glaze, Faience, Stucco etc.), paintings and structures.

6. Museum management and Administration.

Administrative set-up and control; Governing Body and other committees/Societies; Rules and procedures; Human resource planning and Management; Financial management; Marketing and Public relations; Museum, heritage and tourism; Information management.
