No.GS/2022/01/PSC/22/2009/176270/R :- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of Deputy Section Officer, Class III, in the Gujarat Public Service Commission, namely :-

1. These rules may be called the Deputy Section Officer, Class III, in the Gujarat Public Service Commission Recruitment Rules, 2022.
2. Appointment to the post of Deputy Section Officer, Class III, in the Gujarat Public Service Commission, shall be made either,
  - (1) by promotion of a person who possesses 'Good' benchmark for being considered fit for promotion within the zone of consideration as laid down in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967 from amongst the persons, who,-
    - (i) have worked for not less than five years in the cadre of Office Assistant, Class III, in the Gujarat Public Service Commission;
    - (ii) have passed the prescribed departmental examination for promotion to the post of Deputy Section Officer, Class III in the Gujarat Public Service Commission and
    - (iii) have passed the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency (Training and Examination) Rules, 2006;

Provided that where the appointing authority is satisfied that a person having the experience as specified in sub clause (i) above is not available for promotion and that it is necessary in the public interest to fill up the post by promotion even of a person having experience for a lesser period; it may, for reasons to be recorded in writing, promote such person who possesses experience of a period of not less than two-thirds of the period as specified in sub clause (i) above; Or

- (2) on the basis of the result of the competitive examination held for the purpose.

3. The Appointment by promotion and on the basis of the result of the competitive examination held for the purpose shall be made in the ratio of 1:2 respectively.
4. To be eligible for appointment to the post mentioned in rule 2 on the basis of the result of the competitive examination held for the purpose, a candidate shall,
  - (a) not be more than 35 years of age;
  - (b) possess-
    - (i) a bachelor's degree obtained from any of the Universities established or incorporated by or under the Central or a State Act in India; or any other educational institutions recognized as such or declared to be deemed as a University under section 3 of the University Grants Commission Act, 1956; or possess an equivalent qualification recognized by the Government;
    - (ii) the basic knowledge of computer application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules 1967; and
    - (iii) Adequate knowledge of Gujarati or Hindi or both.
5. The provisions of rule 9A of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967 shall be applicable in respect of a candidate appointed on the basis of the result of the competitive examination held for the purpose.
6. The candidate appointed either on the basis of the result of the competitive examination held for the purpose or by promotion shall be required to undergo such training and pass such examination as may be prescribed by the Government.
7. The candidate appointed on the basis of the result of the competitive examination held for the purpose shall be required to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by the Government.
