Note :-

- (1) The candidate at Rank No. 11 (S.T. Divyang), is to be recommended for appointment on unreserved post as per Government circular, GAD No. PVS-1099-MM-13-G4 dated 29-1-2000 and PVS-2010-03-900-G4, dated 23/07/2004, as he has not availed any relaxation.
- (2) The SEBC candidates at Rank Nos. 05, 06, 07 and 08, though secured their place in the merit of general category, they are to be recommended against the posts reserved for SEBC category, as per Government circular, GAD No. PVS-1099-MM-13-G4 dated 29-1-2000 and PVS-2010-03-900-G4, dated 23/07/2004, as they have availed the benefit of relaxation in qualifying standard in the preliminary test.
- (3) 01 post of SEBC and 03 posts of S.T. Category remained vacant, as no suitable candidates were available for the same.
- (4) The above result shall be subject to the final decision of the Honorable High Court in S.C.A. No. 18458 of 2017.
