Note :-

- (1) The S.C. Category candidates at Rank Nos. 01, 02 and 04 are to be recommended for appointment on unreserved posts as per Government circular, GAD No. PVS-1099-MM-13-G4 dated 29-1-2000 and PVS-2010-03-900-G4, dated 23/07/2004, as they have not availed any relaxation.
- (2) The SEBC Female category candidates at Rank Nos. 06 and 08, though secured their place in the merit of General Female category, however they are to be recommended for appointment against the posts reserved for SEBC category, as per Government circular, GAD No. PVS-1099-MM-13-G4 dated 29-1-2000 and PVS-2010-03-900-G4, dated 23/07/2004, as they have availed the benefit of relaxation in qualifying standard in the preliminary test.
- (3) The required No. of women candidates of General category could not be selected even after relaxing 10 % of the Minimum Qualifying Standard prescribed for the candidates of General category.
- (4) **The Weighted Marks of Preliminary Test & Interview are calculated as follows :-**
[Marks obtained in P.T. X 50/300 = Weighted Marks of Preliminary Test] + [Marks obtained in Interview X 50/100 = Weighted Marks of Interview] = Total Weighted Marks
- (5) The result of Kum. Dipti Nareshkumar Shukla, bearing E. No. 39 is kept in "Sealed Cover".
- (6) The above result shall be subject to the final decision of the Hon'ble High Court in S.C.A. No. 2734/2018.
