The Gujarat Provincial Municipal Corporation Act, 1949 GMC/MKM/F.H. 148/R.R./ 6554/2018.

No.....: In exercise of the powers conferred by the sub section (3) of section 457 of the Gujarat Provincial Municipal Corporation Act, 1949, the Gandhinagar Municipal Corporation hereby makes the following rules to provide for regulating recruitment to the post of Biologist, in the Gandhinagar Municipal Corporation, namely:-

- (a) These rules may be called the Biologist, in the Gandhinagar Municipal Corporation Recruitment Rules, 2018.
 - (b) They shall come into force at once.
- Appointment to the post of Biologist, in the Gandhinagar Municipal Corporation shall be made either:-
 - (a) by promotion of a person of proved merit and efficiency from amongst the persons who:
 - (i) have worked for not less than seven years in cadre of Assistant Entomologist, in the Gandhinagar Municipal Corporation;
 - (ii) have passed the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency (Training and Examination) Rules, 2006; or the examination for computer knowledge as may be prescribed by the Gandhinagar Municipal Corporation; and
 - (iii) possess the educational qualifications as prescribed in clause (b) of rule 3 for direct selection.

Provided that where the appointing authority is satisfied that a person having the experience specified in sub clause (i) above is not available for promotion and that it is necessary in the public interest to fill up a post by promotion even of a person having experience for a lesser period; it may, for reasons to be recorded in writing, promote such person who possesses experience of a period of not less than two thirds of the period specified in sub clause (i) above; or

- (b) by direct selection.
- (c) by temporary transfer on deputation basis from amongst the persons working on the cadre of District Malaria Officer or equivalent cadre, Class-II, in Government Department and who possess the educational qualification as prescribed in sub rule (b) of rule 3 of these rules
- To be eligible for appointment by direct selection to the post mentioned in rule
 2, a candidate shall
 - (a) not be less than 18 years and not be more than 35 years of age;

Provided that the upper age limit may be relaxed in favour of a candidate belonging to Scheduled Castes or Scheduled Tribes or Socially and Educationally Backward Classes or Economically Weaker Sections or Women in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967.

(b) possess

- (i) a Bachelor degree in science in the subject of Biology of any of the Universities established or incorporated by or under the Central or State Act in India or any other educational institution recognized as such or declared to be a deemed university under section 3 of the University Grants Commission Act, 1956.
- (ii) the basic knowledge of computer application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967, and
- (iii) adequate knowledge of Gujarati or Hindi or both.
- The candidate appointed by direct selection shall be on probation for a period of two years.

- 5. The candidate appointed by direct selection shall during his probation period, be required to pass the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency (Training and Examination) Rules, 2006 or the examination for computer knowledge as may be prescribed by the Gandhinagar Municipal Corporation.
- The candidate appointed by direct selection will be required to pass an examination in Hindi or Gujarati or both in accordance with the rules prescribed by the Gandhinagar Municipal Corporation.
- The candidate appointed either by direct selection or by promotion shall have to undergo such training and to pass such examination as may be prescribed by the Gandhinagar Municipal Corporation.
- The candidate appointed by direct selection will be required to furnish a
 security and surety bond in such form, for such amount and for such period as
 may be prescribed by the Gandhinagar Municipal Corporation.
