The Gujarat Provincial Municipal Corporation Act, 1949 No CRITIC MKM/EN-148/RR./12846/2020
In exercise of the powers conferred by the sub-section (3) of section 457 of the Gujarat Provincial Municipal Corporation Act, 1949, the Gandhinagar Municipal Corporation hereby makes the following rules to provide for regulating recruitment to the post of Additional Assistant Engineer (Electrical), in the Gandhinagar Municipal Corporation, namely:-

- (a) These rules may be called the Additional Assistant Engineer (Electrical), in the Gandhinagar Municipal Corporation Recruitment Rules, 2020.
 - (b) They shall come into force at once.
- Appointment to the post of Additional Assistant Engineer (Electrical), in the Gandhinagar Municipal Corporation shall be made by direct selection.
- To be eligible for appointment by direct selection to the post mentioned in rule – 2, a candidate shall –
 - (a) not be less than 18 years and not be more than 35 years of age;

Provided that the upper age limit may be relaxed in favour of a candidate belonging to Scheduled Castes or Scheduled Tribes or Socially and Educationally Backward Classes or Economically Weaker Sections or Women in accordance with the provisions of the sub rule (2) of rule 8 of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967.

(b) possess

 a degree in Electrical Engineering of any of the Universities established or incorporated by or under the Central or State Act in India or any other educational institution recognized as such or declared to be a deemed university under section 3 of the University Grants Commission Act, 1956; or

- (ii) diploma in Electrical Engineering obtained from Technical Examination Board or any of the Universities established or incorporated by or under the Central or State Act in India or any other educational institution recognized as such or declared to be a deemed university under section 3 of the University Grants Commission Act, 1956 and have at least two years experience in the field of Electrical Engineering in Government or local bodies or Government undertaking board or corporation or limited company established under the companies Act, 1956,
- (c) possess the basic knowledge of computer application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967, and
- (d) possess the adequate knowledge of Gujarati or Hindi or both.
- 4. Notwithstanding anything contained in any rules, a candidate selected by direct recruitment shall be appointed on contract basis for five years on such terms and conditions as prescribed by the Gandhinagar Municipal Corporation.
- 5. The candidate appointed under rule 4, shall be given the prescribed pay scale of the post of Additional Assistant Engineer (Electrical), after completion of contractual period, on his performance being found satisfactory during the stipulated period of service on contract basis.
- 6. The candidate appointed under rule 4, shall during the stipulated period of service on contractual basis, be required to pass the CCC examination for computer knowledge as prescribed in Gujarat Civil Services Computer Competency (Training and Examination) Rules, 2006 or the examination for computer knowledge as may be prescribed by the Gandhinagar Municipal Corporation.

- 7. The candidate appointed in accordance with rule-4 shall, after regular appointment, be required to pass an examination of Hindi or Gujarati or both, as the case may be, in accordance with the rules prescribed by the Gandhinagar Municipal Corporation.
- The candidate appointed by direct selection shall have to undergo such training and to pass such examination as may be prescribed by the Gandhinagar Municipal Corporation.
- The candidate appointed by direct selection shall be required to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by the Gandhinagar Municipal Corporation.
