Note :-

- (1) The S.C. Category Female candidates at Merit Nos. 22 and 29 are to be recommended for appointment on unreserved posts as per G.A.D. Circular No. PVS-1099-MM-13-G4, dated 29/01/2000 and PVS-2010-03-900-G4, dated 23/07/2004 as they have not availed any relaxation in qualifying standard in the Written Examination.
- (2) The S.C. Category candidates at Merit Nos. 07 and 23, though secured their place in the merit of General Category, however they are to be recommended for appointment against the posts reserved for S.C. Category, as per G.A.D. Circular No. PVS-1099-MM-13-G4, dated 29/01/2000 and PVS-2010-03-900-G4, dated 23/07/2004 as they have availed the benefit of relaxation in qualifying standard in the Written Examination.
- (3) The S.C. Category candidate bearing E. No. 23, Shri Sachinkumar Kishorbhai Sumara, has obtained more marks than the cut-off marks of General Category candidate. As he has availed the benefit of relaxation in qualifying standard in the Written Examination, he is to be considered as an S.C. Category candidate. But both the posts reserved for S.C. Category have already been filled up, he has been declared unsuccessful.
- (4) In case of equal marks, the merit is assigned on the basis of merit-cum-seniority.
- (5) 01 post of S.T. Category in Sachivalay Cadre remains vacant, as no candidate was available for the interviews.
- (6) The final result declared on 13th April, 2023, for the posts of Section Officer, Class-II, in Gujarat Legislature Secretariat Cadre remains unchanged.
- (7) The above result shall be subject to the final decision of the Hon'ble High Court in S.C.A. No. 15710 of 2022.
