CONSTITUTION OF INDIA

No. GH/SH/11/2016/MKM/10/2014/54600/CHH :- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of Child Marriage Prevention Officer Cum District Social Defence Officer, Class II, in the General State Service, under the Directorate of Social Defence, Gujarat State, namely:-

1. These rules may be called the Child Marriage Prevention Officer Cum District Social Defence Officer, Class II, in the Directorate of Social Defence, Recruitment Rules, 2016.
2. In these rules unless the context otherwise requires, Child Marriage Prevention Officer Cum District Social Defence Officer, means the posts included in the annexure I, annexed to these rules.
3. In these rules unless the context otherwise requires Chief Officer means the posts included in the annexure II, annexed to these rules.
4. Appointment to the post of Child Marriage Prevention Officer Cum District Social Defence Officer, Class II, in the General State Service, under the Directorate of Social Defence, Gujarat State, shall be made, either,-
 - (a) by promotion of a person of proved merit and efficiency from amongst the persons, who,-
 - (i) have worked for not less than seven years in the cadre of Chief Officer and its equivalent post, Class III in the subordinate service of the Directorate of Social Defence, Gujarat State; and
 - (ii) have passed the departmental examination as may be prescribed by the Government; and

- (iii) have passed the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006:

Provided that where the appointing authority is satisfied that a persons having an experience as specified in sub-clause (i) above is not available for promotion and that it is necessary in the public interest to fill up the post by promotion even of a person having experience for a lesser period; it may, for reasons to be recorded in writing, promote such person who possesses experience of a period of not less than two-thirds of the period specified in sub-clause (i) above; or

(b) by direct selection.

5. The appointments by direct selection and promotion shall be made in the ratio of 1:2 respectively.
6. To be eligible for appointment by direct selection to the post mentioned in rule 2, a candidate shall-
- (a) not be more than 35 years of age:

Provided that the upper age limit may be relaxed in favour of a candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967:

Provided further that nothing contained in clause (b) of sub-rule (9) of rule 8 of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967 shall be applicable in so far as relaxation of upper age limit as prescribed above is concerned.

(b) possess-

- (i) a Post Graduate degree in Social work or Sociology or Psychology obtained from any of the Universities established or incorporated by or under the Central or State Act in India; or any other educational institutions recognised as such or declared to be deemed as a University under section 3 of the University Grants Commission Act, 1956;
- (ii) the basic knowledge of computer application as prescribed in Gujarat Civil Services Classification and Recruitment (General) Rules, 1967; and
- (iii) adequate knowledge of Gujarati or Hindi or both.
- (c) (i) have about 3 years experience on the post not below the rank of Probation Officer or equivalent post, Class III, in the subordinate service of the Directorate of Social Defence, Gujarat State, or
- (ii) have about 3 years experience in the field of social work or social administration in the Government or Local Bodies or Government undertaking Board or Corporation or Limited Company established under the companies Act, 2013 or University or registered Non-Government Organisation on the post which can be considered as the post not below the rank of Probation officer or equivalent post, class III, in the subordinate service of the Directorate of Social Defence, Gujarat State.
7. The candidate appointed by direct selection shall be on probation for a period of two years.
8. The candidate appointed by direct selection shall, during his probation period, undergo pre-service training and pass the post-training examination in accordance with the provisions of the Gazetted Officers (Pre-Service Training and Examination) Rules, 1970.

9. The candidate appointed by direct selection shall, during his probation period, pass the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006.
10. The candidate appointed by direct selection shall require to pass an examination in Hindi or Gujarati in accordance with the rules prescribed by the Government.
11. The candidate appointed by direct selection shall require to pass the departmental examination as may be prescribed by the Government.
12. The candidate appointed either by direct selection or by promotion shall undergo such training and pass such examination as may be prescribed by the Government.
13. The candidate appointed by direct selection shall require to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by the Government.

Minutes Of meeting held on Dt. 05/09/2013

Social Justice & Empowerment Department

A meeting to finalize 10 year recruitment calendar for the cadres of Social Justice & Empowerment Department met on 05/09/2013 at committee room 1, 4th Floor, Block No -1, Sachivalaya headed by Dr. Hasmukh Adhia, Principal Secretary, Finance Department.

a. In the beginning, Principal Secretary (SJED) made a detailed presentation about organizational structure under three Heads of Department offices and cadres under each one of them.

After detailed discussions, the members present in the meeting unanimously decided as follows in respect of cadres under respective Directorates:

Directorate of Social Defence

- (a) The cadres of Workshop Supervisor (3 posts), Jr. Workshop Supervisor (1 post), Binder / Sr. Attendant (3 posts), Compositor (1 post), Machine Man (1 post) and Stork Keeper (1 post) are abolished.

- (b) The cadres of Junior Clerk (41 posts), Clerk-Cum-Typist (29 posts), Clerk-Cum-Accountant(4 posts), Clerk-Cum-Cashier (1 post), Clerk cum House Master (7 post), Gujarati Typist(1 post) , Investigator(1 post) and Typist-Cum-Clerk(1 post) are merged. The merged strength will be 85 posts.

Directorate, Scheduled Caste Welfare

- (a) The cadres of Deputy Director (3 posts), District Backward Class Welfare Officer (25 posts) & Vigilance Officer (3 posts) in the Grade Pay of Rs. 5400/- are merged. The merged cadre will be designated as Deputy Director & the merged cadre strength will be 31 posts.
- (b) The cadres of Social Welfare Officer (28 Posts), House Master(6 Posts), Prayog Kendra Sanchalak (5 posts) & Manager(1 post) in the Grade Pay of Rs.4600/- are merged. The merge cadre will be designated as Social Welfare Officer & the merged cadre strength will be 40 posts.
- (c) The cadres of Office Supdt. (26 Posts), Auditor (1 post), Accountant(1 post), Loan Recovery Inspector (1 post), vigilance Inspector (9 Posts), Project Officer (27 Posts), Assistant Social Welfare Officer(5 posts), Warden (61 posts) and Assistant Lady Supdt. (45 Posts) in the Grade Pay or Rs. 4400/- are merged. The merged cadre will be designated as Assistant Social Welfare Officer & the merged cadre strength will be 176 posts.
- (d) The cadres of Head Clerk (7 posts), Social Welfare Inspector (191 Posts), Propaganda Officer (1 post). Accountant (11 Posts) & van Supervisor (3 posts) in the Grade Pay of Rs. 4200/- are merged. The merged cadre will be designated as Social Welfare Inspector. 40 more posts of Social Welfare Inspectors are added to the cadre to take the merged cadre strength to 253 posts.
- (e) The cadres of Senior Clerk (64 Posts), Junior Auditor (2 posts), Senior Clerk Cum-Accountant (2 posts) & Junior Inspector (41 posts) in the Grade Pay of Rs.2400/- are merged. The merged cadre will be designated as Senior Clerk. 10 posts of Sr. Clerk are abolished to give a cadre strength of 99 posts in the Senior Clerk Cadre.
- (f) The cadres of Clerk-Cum-Typist (147 Posts), English Typist (1 post) , Gujarati Typist (3 posts) & Junior Clerk (100 Posts) in the Grade Pay of Rs.1900/- are merged. The merged cadre will be designated as

Junior Clerk. 30 posts of junior Clerk are abolished from the merged cadre strength to give the cadre of Junior Clerk a strength of 221. ✓

(g) The cadre strength of Assistant teacher (Secondary) is revised from 115 posts to 93 posts.

Directorate, Developing Caste Welfare

(a) The cadres of Ashramshala Officer (1 post), NT Welfare Officer (1 post) & Social Welfare Officer (18 posts) in the Grade Pay of Rs. 4600/- are merged. The merged cadre will be designated as Social Welfare Officer. The cadre strength of the merged cadre is increased by 7 posts for the new districts to a total strength of 27 posts. ✓

(b) The cadres of Head Clerk (34 posts), Accountant (9 posts), Assistant Ashramshala Officer (1 post) & Social Welfare Inspector (141 Posts) in the Grade Pay of Rs.4200/- are merged. The merged cadre will be designated as Social Welfare Inspector & the merged cadre strength will be 185 posts. ✓

(c) The cadres of Junior Clerk (15 posts), Clerk-Cum-Typist (24 Posts) & Gujarati Typist (3 Posts) in the Grade Pay Of Rs. 1900/- are merged. The merged cadre will be designated as Junior Clerk. The cadre strength of the merged cadre is increased to 79 by creating 37 additional posts. ✓

(d) The cadre strength of Assistant Social Welfare Officer is revised from 120 posts to 127 posts. ✓

(e) The cadre strength of Senior Clerk is revised from 104 posts to 74 posts. ✓


(f) The cadre strength of Assistant teacher is revised from 251 posts to 286 posts. This takes in to account abolition of strength of teachers due to shifting of 8th standard and creation of new posts for introduction of 12th standard in Adarsh Nivasi Shalas.


C. Department will prepare recruitment rule for each of the above mentioned cadres which are being created new and will scrutinize Recruitment Rule for other existing cadres for the following:


- (i) Age limit


If this has not been finalized, Department was advised to have that determined expeditiously.
