No. GS/11/AAK/102020/297/S:- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of Deputy Director, Class I, in the Gujarat Statistical Services, under the General Administration Department (Planning), namely :-

1. These rules may be called the Deputy Director, Class I, in the Gujarat Statistical Services, under the General Administration Department (Planning) Recruitment Rules, 2021.
2. In these rules unless the context otherwise requires Deputy Director means a post included in the Annexure annexed to these rules.
3. Appointment to the post of Deputy Director, Class I, in the Gujarat Statistical Services, under the General Administration Department (Planning) shall be made either,-
  - (A) (a) by promotion of a person who possesses 'Good' benchmark for being considered fit for promotion within the zone of consideration as laid down in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967 from amongst the persons who,
    - (i) have worked for not less than eight years in the cadre of Research Officer, Class II, in the Gujarat Statistical Service;
  - and

(ii) have passed the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006 :

Provided that where the appointing authority is satisfied that a person having the experience as specified in sub-clause (i) above is not available for promotion and that it is necessary in the public interest to fill up the post by promotion even of a person having experience for a lesser period; It may, for reasons to be recorded in writing, promote such person who possesses experience of a period of not less than two-thirds of the period as specified in clause (i) above; Or

(b) by promotion on the basis of the result of the Special Competitive Examination of a person who possess 'Good' benchmark for being considered fit for promotion within the zone of consideration as laid down in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967. from amongst the persons who:-

(i) have worked for not less than five years in the cadre of Research Officer, Class II, in the services of the Gujarat Statistical Service, Class II, in the General Administration Department (Planning);

(ii) possess a bachelor's degree in Statistics or Applied Statistics or Mathematical Statistics or Business Statistics or Economics or Applied Economics or Business Economics or Econometrics or Mathematics or Applied Mathematics or Advance Statistics as principal subject of any of the universities established or incorporated by or

under the Central or State Act in India; or any other educational institution recognised as such or declared to be deemed as University under section 3 of the University Grants Commission Act, 1956;

(iii) have passed the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006; and

(iv) have passed the Special Competitive Examination in accordance with the rules prescribed by the Government, or

(B) by direct selection.

4. (a) The appointments by promotion and by direct selection under the sub-clauses (a) and (b) of rule 3 shall be made in the ratio of 3 : 1;

(b) The appointments by promotion from the cadre of Research Officer, Class II, Gujarat Statistical Service, under sub-clauses (a) and (b) of sub-clause (A) of rule-3 shall be made in the ratio of 2 : 1.

5. To be eligible for appointment by direct selection to the post mentioned in rule-2, a candidate shall,

(a) not be more than 42 years of age ;

Provided that the upper age limit may be relaxed in favour of the candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967;

Provided further that nothing contained in clause (b) of



sub-rule (9) of rule 8 of the Gujarat Civil Services Classification and recruitment (General) Rules, 1967 shall be applicable in so far as relaxation of upper age limit as prescribed above is concerned.

(b) (i) possess a post graduate degree with at least second class in Statistics or Applied Statistics or Mathematical Statistics or Business Statistics or Economics or Applied Economics or Business Economics or Econometrics or Mathematics or Applied Mathematics or Advance Statistics as principal subject from any of the universities established or incorporated by or under the Central or State Act in India; or any other educational institution recognised as such or declared to be deemed as a University under section 3 of the University Grants Commission Act, 1956; and

(ii) have about five years experience on the post not below the rank of Research Assistant, Class III, in the Subordinate Services of the Directorate of Economics and Statistics; or

(iii) have about five years experience in the field of carrying collection, compilation, analysis and interpretation of statistical data or conducting and organizing large scale sample surveys, research studies in any of the fields of Agriculture, Animal Husbandry, Forestry, Fisheries, Applied Economics, Labour, Industries, Education, Health, Medicine, Demography or Sociology involving use of modern statistical methods in Government/ Local Bodies/ Government undertaking/ Board/ Corporation/ Limited Company established under the companies Act, 2013/ University/ registered non Government organization/ Banking Organisation on the post which can be

considered equivalent to the post not below the rank of Research Assistant, Class III, in the Subordinate Services of the Directorate of Economics and Statistics; or

- (c) (i) possess a Ph.D. degree in Statistics or Applied Statistics or Mathematical Statistics or Business Statistics or Economics or Applied Economics or Business Economics or Econometrics or Mathematics or Applied Mathematics or Advance Statistics as principal subject of any of the universities established or incorporated by or under the Central or State Act in India; or any other educational institutions recognised as such or declared to be deemed as a University under section 3 of the University Grants Commission Act, 1956; and
- (ii) have about two years experience on the post not below the rank of Research Assistant, Class III, in the Subordinate Services of the Directorate of Economics and Statistics; or
- (iii) have about two years experience in the field of carrying collection, compilation, analysis and interpretation of statistical data or conducting and organizing large scale sample surveys, research studies in any of the fields of Agriculture, Animal Husbandry, Forestry, Fisheries, Applied Economics, Labour, Industries, Education, Health, Medicine, Demography or Sociology involving use of modern statistical methods in Government/ Local Bodies/ Government undertaking/ Board/ Corporation/ Limited Company established under the companies Act, 2013/ University/ registered non Government organization/ Banking Organization on the post which can be considered equivalent to the post not below the rank of Research Assistant, Class III, in the Subordinate Services of the Directorate of Economics and Statistics.



(d) possess the basic knowledge of computer application as prescribed in Gujarat Civil Services Classification and Recruitment (General) Rules 1967;

(e) possess adequate knowledge of Gujarati or Hindi or both.

6. The candidate appointed by direct selection shall be on probation for a period of two years.

7. The candidate appointed by direct selection shall during his probation period, be required to undergo pre-service training and to pass the post-training examination in accordance with the provisions of the Gazetted Officer's Pre-service Training and Examination Rules, 1970.

8. The candidate appointed by direct selection shall during his probation period, be required to pass the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006.

9. The candidate appointed by direct selection shall be required to pass an examination in Hindi or Gujarati or both in accordance with the rules prescribed by the Government.

10. The candidate appointed either by direct selection or by promotion shall be required to undergo such training and pass such examination as may be prescribed by the Government.

11. The candidate appointed by direct selection shall be required to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by the Government.
