1. The result of the Combined Competitive Examination (Main) for the post of Municipal Chief Officer, Class-III (Advertisement No. 66/2016-17) held on 04-Nov-2017 and 05-Nov-2017 is hereby declared as per **Annexure-I**.
2. The above result is declared taking into consideration the provisions of the Gujarat State Municipal Chief Officer's Service (Competitive Examination) Rules, 2016 as amended from time to time.
3. The Reserved Category Candidates (SC/ST/SEBC), who get qualifying standard for general candidates, and have not availed of any relaxation in age, qualifying standard etc. at any stage of examination are considered against unreserved posts as per proviso under Rule-14(1) of the Gujarat State Municipal Chief Officer's Service (Competitive Examination) Rules, 2016. Number of Category-wise MRC candidates are as under.

Merit No. of MRC (SEBC) Candidates : 2, 21 (Total=2)

4. The following details are relevant in respect of certain candidates who are treated as ineligible for the examination for one reason or the other, the brief details of which are given below :-

All the candidates who had applied online for the Preliminary Examination were allowed to appear for the Preliminary Examination without any scrutiny of the details given in the online applications. The candidates who were declared successful in the Preliminary Examination and allowed to appear for the Main Examination were asked to send the application forms for the Main Examination along-with all the requisite / stipulated documents / certificates. Such candidates were allowed to appear at the Main Examination subject to the verification of the documents / certificates sent by them along-with the application forms for the Main Examination.

- (i) The candidates who have shown the details of sports in the online application and not submitted sports certificate / sports details in the prescribed format or in order were treated as candidates without sports hence the 5% bonus marks of the obtained marks, granted to

the candidate(s) being sports-person during preliminary test was required to be deducted. While doing so, mark of those candidates are appeared below the cut off marks prescribed for the respective category of candidates to be eligible to appear for the Main Examination, become ineligible to appear for the Main Examination. Such **1** candidate bearing Roll No. **102030551** under category SEBC(Female) is therefore declared as unsuccessful in the Preliminary Examination.

- (ii) One candidate, while filling up the online application form, had committed error and mentioned gender as female which was corrected as Male. While doing so, marks of this candidate are appeared below the cut off marks prescribed for the respective category of candidates to be eligible to appear for the Main Examination. This **1** candidate bearing Roll No. **101003229** under category General (Common) is therefore declared as unsuccessful in the Preliminary Examination.
- (iii) Candidates who are eligible to appear for main examination and have not applied for main examination, the candidature of these candidates for the Main Examination have been treated as cancelled by the Commission. There are **six** such candidates.
- (iv) With reference to (i) to (iii) above, necessary orders for ineligibility to appear for the Main Exam/cancellation of candidature are issued by the Commission separately.

- 2 Candidate at Merit No, 2 and 15 of the reserved category (SEBC) have in order of merit, secured their position in the General Merit and not availed the benefit of relaxation at any point of examination therefore these candidates are selected against General category.
- 3 In SEBC (Female) category, the woman candidate is not available hence the 1 seat is allotted to the male candidate of the SEBC Category
- 4 As per provision of Rule 15 of Gujarat State Municipal Chief Officer's Service (Competitive Examination) Rules, 2016 the waiting list shall remain in force as per the instructions issued by the Government in that behalf and as per provision of Rule 16(3) of the said rule, the result in Part-1 shall be published in the Government Gazette.
- 5 Candidates appeared in the Main written Examination and desire for **rechecking of marks**, are requested to send their application along with requisite information and fees as mentioned in the Advertisement for rechecking of marks **within 30 days** from the date of declaration of this result.
- 6 Candidates appeared in the Main written Examination and desire to receive Marksheet of Main Examination, are requested to send their application along with requisite information and fees as mentioned in the Advertisement **within 15 days** from the date of declaration of this result.
- 7 **Applications received beyond the above time limit shall be not considered.**
