- (2) The candidate at Merit No. 12, Shri Hardik Dineshbhai Mistry, bearing E. No. 26, is to be recommended for appointment on unreserved post as per Government circular, GAD No. PVS-1099-MM-13-G4 dated 29-1-2000 and PVS-2010-03-900-G4, dated 23/07/2004, as he has not availed any relaxation.
- (3) With regards to women reservation as provided for, in the Government Notification GAD No. GS/97-13-CRR/1096/2213/G-2, dated 9th April, 1997 and GAD Circular No CRR/1096/2213/G-2 dated 22nd May, 1997,. 06 women candidates (General-04, SEBC-01, and ST-01) are required to be selected. As against this, no woman candidate was available for the Interviews.
- (4) 02 posts of S.T. category remained vacant, as no candidate was available for the interview.
- (5) The candidature of 16 candidates have been cancelled, as they do not possess the required Physical standards, prescribed in the Advertisement.
- (6) The above result shall be subject to the final decision of the Honourable High Court in S.C.A. No. 6277/2018.
