No: GR/2022/30-A/TLM/13/2021/469991/R(1):- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of Legal Officer, Class II, in the Gujarat Skill training service, under the Directorate of Employment and Training, Gujarat state, namely :-

1. These rules may be called the Legal Officer, Class II, under the Directorate of Employment and Training, Recruitment Rules, 2022.
2. Appointment to the post of Legal Officer, Class II, under the Directorate of Employment and Training, Gujarat state, shall be made either -
  - (a) by promotion of a person who possesses "Good" benchmark for being considered fit for promotion within the zone of consideration as laid down in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967 from amongst the persons who-
    - (i) have worked for not less than seven years in the cadre of Junior apprenticeship advisor for legal matters, in the Gujarat Skill Training Service, class III, under the Directorate of Employment and Training; and
    - (ii) have passed the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006.

Provided that where the appointing authority is satisfied that a person having the experience specified in sub-clause (i) above is not available for promotion and it is necessary in the public interest to fill up the post by promotion even of a person having experience for a lesser period; it may,

for reasons to be recorded in writing, promote such person who possesses experience of a period of not less than two-thirds of the period specified in sub-clause (i) above; or

(b) by direct selection;

3. To be eligible for appointment by direct selection to the post mentioned in rule 2, the candidate shall,

(a) not be more than 41 years of age:

Provided that the upper age limit may be relaxed in favour of the candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967:

Provided further that nothing contained in clause (b) of sub-rule (9) of rule 8 of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967 shall be applicable in so far as relaxation of upper age limit as prescribed above is concerned;

(b) possess a bachelor's degree in law(special)/Bachelor of Legislative Law (LLB) (three years)/ a bachelor's Degree in Law (integrated) of five years course obtained from any of the Universities established or incorporated by or under the Central or a State Act in India; or any other educational institutions recognised as such or declared to be deemed as a University under section 3 of the University Grants Commission Act, 1956;

(c) (i) have about three years of active and continuous experience as an advocate and such an experience certificate shall be certified in case of an advocate practicing in the high court by the Registrar General and in other case by the Presiding Officer of the Court or the Tribunal where he practices as an advocate, or ;

(ii) have about three years experience of legal matters in the Government/ Local Bodies/Government undertaking/ Board/ Corporation/Limited Companies established under the Companies Act, 2013 or a University.

**Explanation** : Legal Matters means all work relating to drafting of legal notice, affidavit, parawise remarks etc, filing of suits, appeals, providing opinion, briefing the concerned Law Officer or Advocate of the concerned court cases pending before various courts.


(d) possess the basic knowledge of computer application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967; and

(e) possess adequate knowledge of Gujarati or Hindi or both.

4. The candidate appointed by direct selection shall be on probation for a period of two years.
5. The candidate appointed by direct selection, during his probation period shall be required to undergo pre-service training and to pass the post-training examination in accordance with the provisions of the Gazetted officer's Pre-service Training and Examination Rules, 1970.
6. The candidate appointed by direct selection, during his probation period shall be required to pass the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006.
7. The candidate appointed by direct selection shall be required to pass an examination in Hindi or Gujarati or both in accordance with the rules prescribed by the Government.
8. The candidate appointed either by direct selection or by promotion shall be required to undergo such training and pass such examination as may be prescribed by the Government.

9. The candidate appointed by direct selection shall be required to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by the Government.
