### **Note :-**

- (1) The SEBC Category candidate at Merit No. 04 and the S.T. Category candidate at Merit No. 05, though secured their place in the merit of General Category, however they are to be recommended for appointment against the posts reserved for their respective categories, as per G.A.D. Circular No. PVS-1099-MM-13-G4, dated 29/01/2000, PVS-2010-03-900-G4, dated 23/07/2004 and PVS-102019-221-G4, dated 07/02/2019, as they have availed the benefit of relaxation in age / Cut-Off Marks in P.T.
- (2) 02 posts of General Category remains vacant as no candidates were available for the interviews.
- (3) The results (Second Minutes) of the petitioners of **S.C.A. Nos. 15045/2018, 11259/2019 and 11734/2023**, who were called for interview conditionally, are kept in 03 separate "**Sealed Covers**".
- (4) **The Weighted Marks of Preliminary Test & Interview are calculated as follows :-**  
[Marks obtained in P.T. X 50/300 = Weighted Marks of Preliminary Test] + [Marks obtained in Interview X 50/100 = Weighted Marks of Interview] = Total Weighted Marks
- (5) The above result shall be subject to the final decision of the Hon'ble High Court in **S.C.A. Nos. 15045/2018, 15071/2018, 15249/2018, 11024/2019, 11259/2019 and 11734/2023**.
