### PARTIAL MODIFICATION

**Read : Final Result-No. 102016-4437-6-R7, dated 10-05-2018**

- 1 In the final result of the posts of Assistant Professor, Sanskrit, at Govt. Arts, Science and Commerce Colleges, Class-II, Advt. No. 74/2016-17, dated 10th May, 2018, **01 post of S.C. Category was kept vacant**, as per the direction of the Hon'ble High Court in oral order dated 01/05/2018 in L.P.A. No. 471 of 2018 in S.C.A. No. 2852 of 2018.
- 2 As per the oral Judgement dated 14-10-2019 of the Hon'ble High Court, in L.P.A. No. 471/2018 in S.C.A. No. 2852 of 2018, Shri Vijaykumar Pravinbhai Bathvar, has been called for interview on 9th December, 2019.
- 3 Shri Vijaykumar Pravinbhai Bathvar has obtained Total weighted marks 43.94.
- 4 In view of the above, the result dated 10th May, 2018, **is modified as under:**
  - (a) As Shri Vijaykumar Pravinbhai Bathvar has obtained ***less marks than the Cut-off Marks for S.C. Category and also less marks than*** the candidates kept on Waiting List for S.C. category, ***he is declared unsuccessful.***
  - (b) The candidate kept at serial No. 01 on the waiting List for S.C. Category, in the result dated 10th May, 2018, Kum. Jasuben Mangabhai Parmar, bearing E.No. 08, ***is now declared successful. She is shifted from the Waiting List and placed at Merit No. 23-A (i.e. between Merit No. 23 & 24)*** in the list of candidates to be recommended to the Government for appointment.
  - (c) Consequently, the serial No. of the candidate kept on Waiting List for S.C. Category, Dr. Daxababen Laljibhai Vagh, bearing E.No. 21, ***is now modified as Serial No. 01.***

(d) The S.C. category candidate, Shri Riteshkumar Dahyabhai Parmar, bearing E.No. 78, shown at serial No. 54 in the list of unsuccessful candidates of the result dated 10<sup>th</sup> May, 2018, ***is now deleted from the list of Unsuccessful candidates and has been kept on Waiting List for S.C. category, at serial No. 02.***
