- (1) The SEBC category candidates at Merit Nos. 07, 09 (Fem.) & 16 and the S.T. category candidates at Merit Nos. 08, 10 (Fem.), 12 & 18 (Fem.), are to be recommended for appointment on unreserved posts as per G.A.D. Circular No. PVS-1099-MM-13-G4, dated 29/01/2000, PVS-2010-03-900-G4, dated 23/07/2004 and PVS-102019-221-G4, dated 07/02/2019, as they have not availed any relaxation in Cut-off Marks in Preliminary Test or in age.
- (2) The SEBC category Female candidates at Merit Nos. 19 & 20, though secured their places in the merit of General category, however they are to be recommended for appointment against the posts reserved for SEBC category, as per G.A.D. Circular No. PVS-1099-MM-13-G4, dated 29/01/2000, PVS-2010-03-900-G4, dated 23/07/2004 and PVS-102019-221-G4, dated 07/02/2019, as they have availed the benefit of relaxation in Cut-Off Marks in the preliminary test.
- (3) 33 posts of General, 17 posts of EWS, 38 posts of SEBC, 07 posts of S.C. and 16 posts of S.T. category remains vacant as no candidates were available for the interviews.
- (4) No Person with Disability and Ex-serviceman candidate was available for the interview.
- (5) **The Weighted Marks of Preliminary Test & Interview are calculated as follows :-**

$$[\text{Marks obtained in P.T.} \times 50/200 = \text{Weighted Marks of Preliminary Test}] + [\text{Marks obtained in Interview} \times 50/100 = \text{Weighted Marks of Interview}] = \text{Total Weighted Marks}$$
