CONSTITUTION OF INDIA.

No. GY-41-(08)-GMS-102004-1362-TH :- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, in supersession of all the rules made in this behalf: the Governor of Gujarat hereby makes the following rules to provide for regulating the recruitment to the post of "Specialist" in the Gujarat Health and Medical Services, Class-I, in the Commissionerate of Health, Medical Services and Medical Education, namely :-

1. These rules may be called the Specialist, Class-I Recruitment Rules, 2008.
2. In these rules, unless the context otherwise requires " Specialist" Gujarat Health and Medical Service, Class-I means a post included in the Annexure annexed to these rules

3. Appointment to the post of Specialist, Class-I, in Gujarat Health and Medical Services, shall be made either:-

- (a) by promotion of a person of proved merit and efficiency from amongst the persons who,--
- (i) Have worked for not less than eight years in the cadre of medical officer in the Gujarat Health and Medical Services, Class-II after acquiring the requisite educational qualification as prescribed in clause (i) of sub rule (c) of rule 4 or clause (ii) of sub rule (c) of rule 4 for the respective post and
- (ii) Have passed the qualifying examination for computer knowledge in accordance with the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006 :

and who have acquired

Provided that where the appointing authority is satisfied that a person having the experience specified in clause (i) above is not available for promotion and that it is necessary in public interest to fill up the post by promotion even of a person having experience for a lesser period; it may, for reasons to be recorded in writing, promote such person who possesses experience for a period of not less than two thirds of the period specified in clause (i) above

Or

(b) By direct selection

4. To be eligible for appointment by direct selection to the post mentioned in rule(3)(b), a candidate shall -

- (a) not be less than 35 years of the age;
- (b) Possess a degree of Bachelor of Medicine and Bachelor of Surgery of any of the Universities established or incorporated by or under the Central or State Act in India; or any other educational institution recognised as such or declared to be deemed as University under section 3 of the University Grant Commission Act, 1956 (3 of 1956); or possess any other qualifications specified in First or Second Schedule to the Indian Medical Council Act, 1956; and
- (c)(i) possess a post-graduate diploma, in respective subject as, shown in the Annexure against the each post, of the Universities established or incorporated by or under the Central or State Act in India; or possess an equivalent qualifications recognized by the Medical Council of India and have experience of two years in Government Hospital or owned manage or controlled by the Non Government Organisation Hospital or Trust Hospital;
- (ii) possess post-graduate Degree, in respective subject as, shown in the Annexure against the each post, of the Universities established or incorporated by or under the Central or State Act in India; or possess an equivalent qualifications recognized by the Medical Council of India;
- (d) possess the basic knowledge of computer application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967 as amended from time to time.
- (e) possess adequate knowledge of Gujarati and / or Hindi.

Provided that the upper age limit may be relaxed in favour of a candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967 as amended from time to time

5. The candidate appointed by direct selection shall be on probation for a period of two years.
6. The selected candidate shall during his probation period be required to pass the qualifying examination for computer Knowledge, in accordance with the provisions of the Gujarat Civil Services computer Competency Training and Examination Rules, 2006.
7. The candidate appointed by direct selection shall, during his probation period be required to undergo Pre-service Training and pass the Post training examination in accordance with the Gazetted Officers Pre-service Training and Examination Rules, 1970.

8. The candidate appointed by direct selection shall be required to pass an examination in Hindi or Gujarati or both in accordance with the rules prescribed by the Government.
9. The selected candidate shall be required to get himself registered under the Gujarat Medical Council Act, 1967 before joining the duty.
10. The selected candidate shall, if so required, be liable to serve if any defence service or post connected with the defence of India for a period of not less than four years including the period, if any, spent in training:
- Provided that the candidate shall
- (a) not be required to serve as aforesaid after the expiry of ten years from the date of his appointment, and
- (b) not ordinarily be required to serve as aforesaid after attaining the age of 45 years.
11. The candidate appointed either by direct selection or by promotion shall have to undergo such training and to pass such examination as may be prescribed by the Government, from time to time.
12. The candidate appointed by direct selection shall be required to furnish a Security and Surety bond in such form, for such amount and for such period as may be prescribed by the Government from time to time, in that behalf.




