**Note :-**

- (1) The SEBC category candidates at Merit Nos. 02, 03, 11, 14 & 15; the S.C. category candidate at Merit No. 16 and the S.T. category candidate at Merit No. 17, are to be recommended for appointment on unreserved posts as per G.A.D. Circular No. PVS-1099-MM-13-G4, dated 29/01/2000, PVS-2010-03-900-G4, dated 23/07/2004 and PVS-102019-221-G4, dated 07/02/2019, as they have not availed any relaxation in Cut-off Marks in Preliminary Test or in age.
- (2) The SEBC category candidate at Merit No. 13 and the S.C. category candidate at Merit No. 19, though secured their place in the merit of General category, however they are to be recommended for appointment against the posts reserved for their respective categories, as per G.A.D. Circular No. PVS-1099-MM-13-G4, dated 29/01/2000, PVS-2010-03-900-G4, dated 23/07/2004 and PVS-102019-221-G4, dated 07/02/2019, as they have availed the benefit of relaxation in Cut-Off Marks in the preliminary test.
- (3) No Person with Disability was available for the interview.
- (4) 02 posts of General, 06 posts of EWS, 12 posts of SEBC, 03 posts of S.C. and 08 posts of S.T. category remains vacant, as no candidates were available for the interviews.
- (5) **The Weighted Marks of Preliminary Test & Interview are calculated as follows :-**  
[Marks obtained in P.T. X 50/200 = Weighted Marks of Preliminary Test] + [Marks obtained in Interview X 50/100 = Weighted Marks of Interview] = Total Weighted Marks
