

NO: GS/2020/20/૧૨૮/10/2006/131(39666)/K :- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Gujarat hereby makes the following rules further to amend the Deputy Section Officer, Class III in the subordinate secretariat services Recruitment Rules, 2018, namely :-

1. These rules may be called the Deputy Section Officer, Class III in the subordinate secretariat services Recruitment (Amendment) Rules, 2020
2. In the Deputy Section Officer, Class III in the subordinate secretariat services Recruitment Rules, 2018, in rule 2, in clause (a), for the words "by promotion of a person of proved merit and efficiency", the words, brackets and figures "by promotion of a person who possess 'good' benchmark for being considered fit for promotion within the zone of consideration as laid down in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967" shall be substituted.

No. GS/ 2018 /29/ અરદ /10/2006/131(39666) /K :- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of Deputy Section Officer, Class III in the subordinate secretariat services, Gujarat State, namely:-

1. These rules may be called the Deputy Section Officer, Class III in the subordinate secretariat services Recruitment Rules, 2018.
2. Appointment to the post of Deputy Section Officer, Class III in the subordinate secretariat services, Gujarat State, shall be made either,
  - a) by promotion of a person of proved merit and efficiency from amongst the persons, who -
    - I. have worked for not less than five years in the cadre of clerk, Class III or English Typist, Class III or Gujarati Typist, Class III or Office Assistant, Class III in the subordinate secretariat services; Gujarat State
    - II. have passed the prescribed departmental examination for promotion to the post of Deputy Section Officer, Class III in the subordinate secretariat services; and
    - III. have passed the qualifying examination for computer knowledge in accordance with the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006:

Provided that where the appointing authority is satisfied that a person having the experience specified in sub-clause (i) above is not available for promotion and that it is necessary in the public interest to fill up the post by promotion even of a person having experience for a lesser period; it may, for reasons to be recorded in writing, promote such person who possesses experience of a period of not less than two-thirds of the period specified in sub- clause (i) above;


or

- b) on the basis of the result of a competitive examination.
3. The appointment by promotion and on the basis of the result of a competitive examination shall be made in the ratio of 1:3 respectively.
4. To be eligible for appointment to the post mentioned in rule 2 on the basis of the result of a competitive examination, a candidate shall,-
  - (a) not be more than 35 years of age;

(b)possess, -

- I. a bachelor's degree obtained from any of the Universities established or incorporated by or under the Central or a State Act in India; or any other educational institution recognised as such or declared to be deemed as a University under section 3 of the University Grants Commission Act, 1956 or possess an equivalent qualification recognised by the Government;
  - II. the basic knowledge of computer application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules 1967; and
  - III. adequate knowledge of Gujarati or Hindi or both.
5. The provisions of rule 9A of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967 shall be applicable in respect of a candidate appointed on the basis of the result of a competitive examination.
6. The candidate appointed either on the basis of the result of a competitive examination or by promotion shall be required to undergo such training and pass such examination as may be prescribed by the Government.
7. The candidate appointed on the basis of the result of a competitive examination shall be required to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by the Government.

**NO/GS/18/2021/CRR/11/2021/450900/G.5:-** In exercise of power conferred by the proviso to the article 309 of the Constitution of India, the Governor of Gujarat hereby makes the following rules further to amend the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967, namely:-

1. These rules may be called the Gujarat Civil Services Classification and Recruitment (General) (Amendment) Rules, 2021.

2. In the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967 after rule 16(F), the following rule shall be inserted, namely:-

"16 G. Notwithstanding anything contained in these rules or in any other rules or orders relating to recruitment to any service or post included in the State, Subordinate or Inferior Services under the State, the upper age limit prescribed for appointment through competitive examination held for the purpose or by direct selection, to such service or post shall be relaxed by one year as far as it relates to the advertisement published by the Gujarat Public Service Commission and all other Recruiting Authorities or Agencies during the period from 1<sup>st</sup> September, 2021 to 31<sup>st</sup> August, 2022. This relaxation in the upper



age limit shall be in addition and subject to the provision and relaxation available under rule 8 or any other rules or orders, if any, made in this behalf".
