GUJARAT MUNICIPALITIES ACT, 1963.

No.KV-269 of 2007/NPM-102005/2054-R:-WHEREAS the Government of Gujarat is of the opinion that it is necessary and expedient so to do for bringing about a uniform and a more efficient service of officers in the municipalities for the purpose of carrying out the functions and duties under the Gujarat Municipalities Act, 1963 (Guj.34 of 1964) (hereinafter referred to as "the said Act")

AND WHEREAS the Government of Gujarat has constituted the Gujarat State Municipal Chief Officers' Services under sub-section (1) of section 47A of the said Act vide Government Order, Urban Development and Urban Housing Department No.KV-599-1994-NPL-1094-5555-R dated the 26th December, 1994;

NOW, THEREFORE, in exercise of the powers conferred by sub-section (1) of section 47A of the said Act, the Government of Gujarat hereby further, -

- (1) constitutes the following municipal services, namely:-
 - (i) Gujarat State Municipal Accounts Officers' Service,
 - (ii) Gujarat State Municipal Engineers' Service;
 - (iii) Gujarat State Municipal Health Officers' Service;
- (2) Directs that the municipal services so constituted shall consist of classes, cadres and posts (including the grade of posts) as specified in the Schedule to this notification;
- (3) Specifies the total strength of the officers in each such class and cadre mentioned in column 6 of the aforesaid Schedule.

"(iii) Gujarat State Municipal Health Service".

(2) in the Schedule,-

(a) In the heading, in part I, for the words "Gujarat State Municipal Accounts' Officers' Service", the words "Gujarat State Municipal Accounts Service" shall be substituted ;

(b) In part-1 in the table at serial no.-2, in the second column, for the words "Municipal Accounts Officer" The words "Municipal Accountant" shall be substituted.

(c) In part-1 in the table at serial no. 3, in the second column, the words "Municipal Accounts officer" The words "Municipal Deputy Accountant " Shall be substituted

(d) In the heading, in part III, for the words "Gujarat State Municipal Health Officers' Service", the words "Gujarat State Municipal Health Service" shall be substituted.

GUJARAT MUNICIPALITIES ACT, 1963

No. : KV-124 of 2012 NPM-122009-3637-R .- In exercise of the powers conferred by sub-section (2) of section 47A of the Gujarat Municipalities Act, 1963 (Guj.34 of 1964), the Government of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of Municipal Accounts Officer, Class II in the Gujarat State Municipal Accounts Service, namely :-

1. These rules may be called the Municipal Accounts Officer, Class II Recruitment Rules, 2012.
2. Definitions: In these rules, unless the context otherwise requires,-
 - (a) "Act" means the Gujarat Municipalities Act, 1963;
 - (b) "Appointing Authority" means the State Government ;
 - (c) "Government" means the Government of Gujarat;
 - (d) "Service" means the Gujarat State Municipal Accounts Service.
3. Appointment to the post of Municipal Accounts Officer, Class II in Gujarat State Municipal Accounts Service, class II shall be made either,-
 - (a) by promotion of a person of proved merit and efficiency from amongst the persons, who,-
 - (i) have worked for not less than seven years in the cadre of Municipal Accountant, Class III, in the Gujarat State Municipal Accounts Service;
 - (ii) have passed the departmental examination as may be prescribed by the Government;
 - (iii) have passed the qualifying examination for computer knowledge in accordance with the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006:

Provided that where the appointing authority is satisfied that a person having the experience specified in sub-clause (i) is not available for promotion and that it is necessary in the public interest to fill up the post by promotion even of a person having experience for a lesser period; it may, for reasons to be recorded in writing, promote such person who possesses experience of a period of not less than two-thirds of the period specified in sub-clause (i); or

(b) by direct selection;

4. To be eligible for appointment by direct selection to the post mentioned in rule 3, a candidate shall,—

(a) (i) not be more than 30 years of age;

(ii) possess the adequate knowledge of Gujarati or Hindi or Both,

(b) possess -

(i) the degree of Chartered Accountant or Cost and works Accountant or Company Secretary, or

(ii) a Master degree in Business Administration or Master of Computer Application or Master of Commerce or Master of Science (in Mathematics / Statistics), or Master of Arts (in Statistics / Economics / Mathematics) obtained from any of the Universities established or incorporated by or under the Central or a State Act in India; or any other educational institution recognized as such by the Government or declared to be deemed as a University under section 3 of the University Grants Commission Act, 1956; or possess an equivalent qualification recognized by the Government; or

(iii) a Bachelor degree with second class in Business Administration or Bachelor of Computer Application or Bachelor of Commerce or Bachelor of Science in Mathematics / Statistics or Bachelor of Arts in Statistics / Economics / Mathematics obtained from any of the Universities established or incorporated by or under the Central or a State Act in India; or any other educational institution recognised as such by the Government or declared to be deemed as a University under section 3 of the University Grants Commission Act, 1956; or possess an equivalent qualification recognised by the Government; and

(c) Possess the basic knowledge of computer application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules 1967.

Provided that the upper age limit may be relaxed in favour of a candidate belonging to Scheduled Castes or Scheduled Tribes or Socially and Educationally Backward Classes or Woman in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967.

5. The candidate appointed by direct selection shall be on probation for a period of two years.
6. The candidate appointed by direct selection shall during his probation period be required to pass the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Service Computer Competency, Training and Examination Rules, 2006.
7. The candidate appointed by direct selection shall, during his probation period be required to undergo pre-service training and pass the post-training examination in accordance with the rules as may be prescribed by the Government in that behalf.
8. The candidate appointed by direct selection shall be required to pass an examination in Hindi or Gujarati or both in accordance with the rules as may be prescribed by the Government in that behalf.
9. The selected candidate shall be required to pass the departmental examination in accordance with the rules as may be prescribed by the Government in that behalf.
10. The candidate appointed by direct selection shall have to undergo such training and pass such examination as may be prescribed by the Government.
11. The candidate appointed by direct selection shall be required to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by the Government.

12. The following rules shall mutatis mutandis apply to the Municipal Accounts Officer, Class II, namely :-
- (1) The Gujarat Civil Service (Pay) Rules, 2002.
 - (2) The Gujarat Civil Service (Additions to Pay) Rules, 2002.
 - (3) The Gujarat Civil Service (General Conditions of Services) Rules, 2002.
 - (4) The Gujarat Civil Service (Traveling Allowance) Rules, 2002.
 - (5) The Gujarat Civil Service (Occupation of Government Residential Accommodation) Rules, 2002.
 - (6) The Gujarat Civil Service (Joining Time, Foreign Service, Deputation out of India, Payment during suspension, Dismissal and Removal) Rules, 2002.
 - (7) The Gujarat Civil Service (Leave) Rules, 2002.
 - (8) The Gujarat Civil Service (Pension) Rules, 2002.
 - (9) The Gujarat Civil Service (Conduct) Rules, 1971.
 - (10) The Gujarat Civil Service (Discipline and Appeal) Rules, 1971.
 - (11) The Gujarat Civil Service Classification and Recruitment (General) Rules, 1967.
 - (12) Contributory Provident Fund Rules and (Bombay) General Provident Fund Rules.

No: KV 149 of 2016-NPM-122009-3637-R:-In exercise of the powers conferred by sub-section(2) of section 47A of the Gujarat Municipalities Act, 1963 (Guj.34 of 1964), the Government of Gujarat hereby makes the following rules further to amend the Municipal Accounts Officer, Class-II, Recruitment Rules, 2012, namely:-

1. These rules may be called the Municipal Accounts Officer, Class-II, Recruitment (Amendment) Rules, 2016.
2. In the Municipal Accounts Officer, Class-II Recruitment Rules, 2012, in rule 4,
 - (i) for clause (a), the following clause shall be substituted, namely:-
"(a) not be more than 37 years of age: ✓


Provided that the upper age limit may be relaxed in favour of a candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967:

Provided further that the upper age limit may be relaxed in favour of a candidate of a Scheduled Caste, Scheduled Tribe, Socially and Educationally Backward Class, Economically Weaker Section and in favour Woman in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967:

Provided also that nothing contained in clause (b) of sub- rule (9) of rule 8 of the Gujarat Civil Services Classification and Recruitment (General) rules, 1967 shall be applicable in so far as relaxation of upper age limit as prescribed above in concerned";

- (ii) the existing proviso after clause (c) shall be deleted;
- (iii) after clause (c), the following clause shall be added namely:-
“(d) possess the adequate knowledge of Gujarati or Hindi or both.”
