2 The candidate at Merit No. 06, though secured her place in the merit of General Category, however she is to be recommended for appointment against the post reserved for SEBC Female Category, as per Government circular, GAD No. PVS-1099-MM-13-G4 dated 29-1-2000 and PVS-2010-03-900-G4, dated 23/07/2004, as she has availed the benefit of relaxation in qualifying standard in the preliminary

test. Also the required number of women candidates of General Category could not be selected, even after relexing 10% of the cut off marks derived for General Category candidates.
